RE: Honorary street naming between 6th and 9th of W. Virginia St.

To whom it may concern,

In 1907, a woman in Milwaukee named Mae Elizabeth Dey, defied the norms of society and started a company. Born in Appleton, where she received a high school education, she moved to Milwaukee to enter Commercial College, studying bookkeeping and stenography. In 1901, she accepted a position with Mr. Matthew J Hogan, Custom House Broker at 818 Goldsmith Building, south of the Pfister Hotel, for whom she acted as his private secretary. Mr. Hogan passed away and the Collector of Customs requested Ms. Dey to accept the office as Custom House Broker in the Port of Milwaukee, the fifth female Broker in the United States. When in 1910, Congress required formal licensing of Brokers, Ms. Dey or rather M.E. Dey & Company, was issued license number 1 in our Customs port. Ms. Dey was a member of the then World Trade Club, Treasurer of the Isabella Organization and active in bowling, golf and swimming. She also operated 'Dey's Orchestra, in which she played woodwinds.

M.E. Dey grew along with Milwaukee. As is often the case, mostly employing family members, including her niece Lillian and nephew Rolland Gardenier. By 1928, her salary was \$1950 (roughly \$28,000 today). At her death in 1929, she was buried at Cavalry Cemetery. Her nephew Rolland took over running the company, beginning the ownership of the Gardenier family, of which continues today.

In 2018, M.E. Dey & Co., is celebrating its 111th anniversary in business. Robert Gardenier, Mae's Great-Grand Nephew, is the fourth generation family member to lead the company. Mae's vision of guiding Milwaukee's companies in their expansion of international trade continues. With her strength of understanding international business and mentorship for the next generation, the company survived economic crashes, wars, recessions, changes in trade policy, and is heading into its fifth generation.

I request the Committee approve naming the blocks between 6th and 9th of W. Virginia Street as "Honorary M.E. Dey & Co" for several reasons. Mae Elizabeth Dey was a person of exceptional significance for the City of Milwaukee, as the founder of M.E. Dey & Co, having been granted the first licensed Customhouse Broker in Milwaukee (July 25, 1910), and as person involved in the continued evolution of our international trade industry. The area of this request is very significant, as the Trade Center, located on 7th and Virginia, was the epicenter of steamship lines who imported and exported goods/machinery worldwide via the Great Lakes. Also, Pfister & Vogel, a powerhouse in the tanning industry, located for many years between 6th and 9th and Virginia, was a long term customer of M.E. Dey & Co. Finally, after 111 years of existence, today's M.E. Dey offices are located within the a Pfister and Vogel building on 700 W. Virginia.

As an employee of M.E. Dey & Co., for almost 25 years, it is my pleasure to participate in applying for this honorary naming opportunity for Mae Elizabeth Dey's company. She was a historical founder and amazing woman.


