Good afternoon,

My Name is _____ and I would like to file a formal complaint against Scrap America LLC and all of their Alias & DBA entities. On December 16th 2024 my vehicle was stolen from the Wyndham Ramada Hotel at 2301 W. Wisconsin Avenue in Milwaukee, Wisconsin. I filed a police report and a few days later realized that my truck stamped an address in the Toyota App where it was last parked. That address was across the alley from where my vehicle was hidden in a garage located at 3738 N. 17th Street in Milwaukee. I learned that the address my vehicle tracked was a friend who was able to review his cameras and saw my vehicle the day it was stolen, the individuals that stole my vehicle as well as a tow truck and its operator, removing my truck from the address where it was parked. After my friend provided me with pictures from the video footage, I then reached out to the police, my family and friends. One of my relatives was able to identify the man that towed my vehicle and let him know that my vehicle that was in his possession was stolen and he needed to return it immediately. I shared the additional information with the police and they had me upload the photo's to a link. I also contacted 7th district to let them know that my vehicle may be housed on the lot of the business that picked my truck up. While at 7th district I contacted Toyota and they informed the officer I was speaking with that my truck was taken to another address 1215 N. 23rd street. This address was the last location Toyota was able to track my vehicle at and it was in the possession of Scrap America LLC.

December 20th 2024 my relative contacted the owner KC and he stated that my vehicle would be returned and asked my cousin to ask me to not get the police involved. On December 23rd I was contacted by my relative to meet him at the location my vehicle was being stored at 3232 W. Fond Du Lac Avenue and retrieved my vehicle with two busted back windows(rear left passenger and the small right passenger window), the rear view mirror detached from the windshield, a broken grill and other dinks that may have happened in the process of being towed. Most of my personal items removed from my vehicle that included some keys and a storage fob as well as my vehicle registration, leather gloves and other miscellaneous items.

When I went to retrieve my vehicle, the owner KC showed a drivers license of the woman and a brief video of her stating that she was the owner. KC then asked me to verify ownership and I showed him my driver's license, my Toyota app with my information on it and a receipt I had still in the truck with my name on them. On the same day I went to district 7 to have my vehicle finger printed and took my vehicle to Andrew Toyota to get an estimate of the cost for damages to my vehicle. I contacted KC at (414) 444-8059 on January 2nd to discuss the damages that happened while my vehicle was in his company's possession. He argued with me that the vehicle was in that condition when he received it and that he is not liable. KC then stated I needed to contact the individuals that stole my vehicle for the damages. I explained to him that it is his responsibility to make sure he is not picking up stolen property and that if he didn't know the vehicle was stolen why did he take my truck to another location to have the rear view mirror removed to stop Toyota from tracking it? KC demanded I give him the video footage and that he is not liable and he was not going to repair the damages to my vehicle and that I need to contact the woman who said it was her vehicle. The estimated damages are close to ten thousand dollars. I would like my vehicle fixed and his company held responsible for taking stolen property. I have attached photo's for your review of the incident and have access to retrieve the actual footage from my friend.

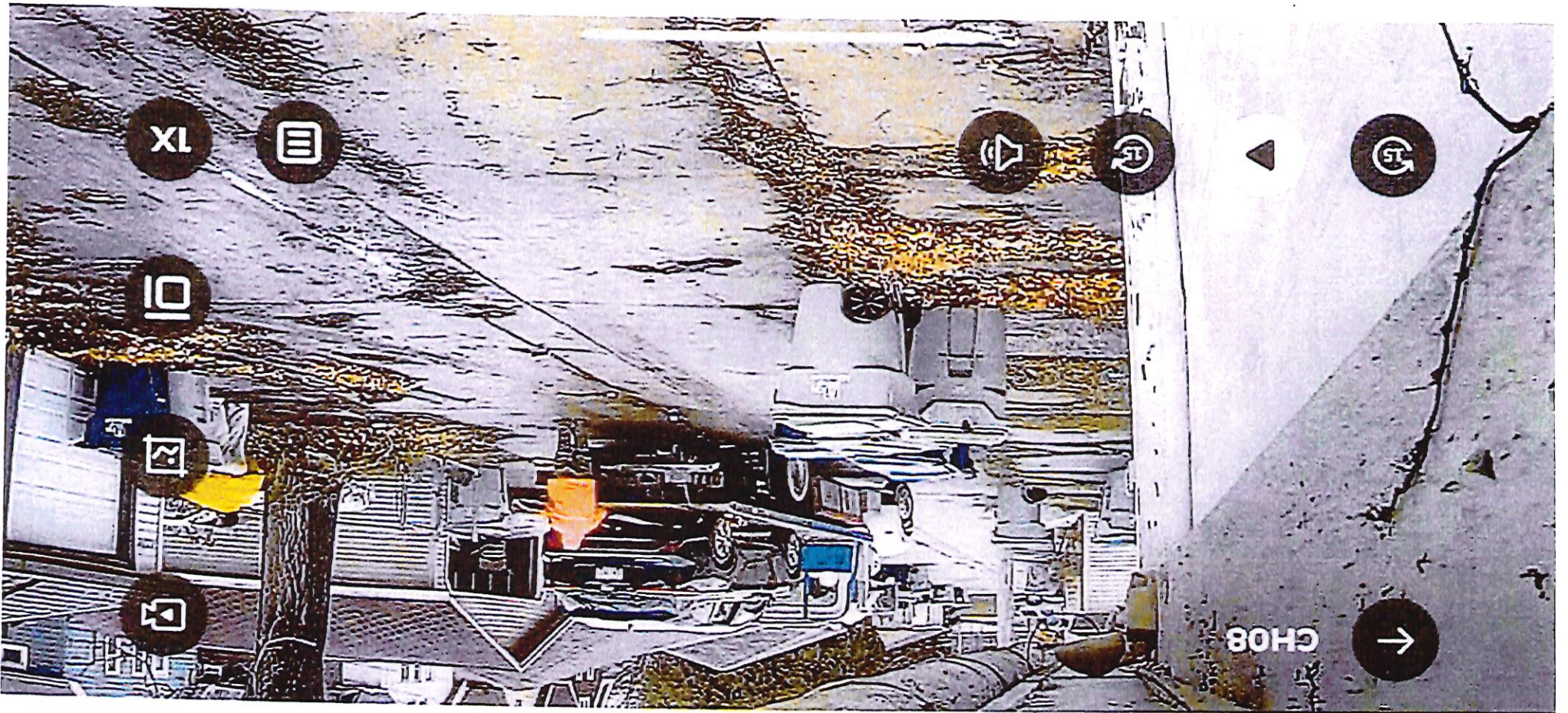

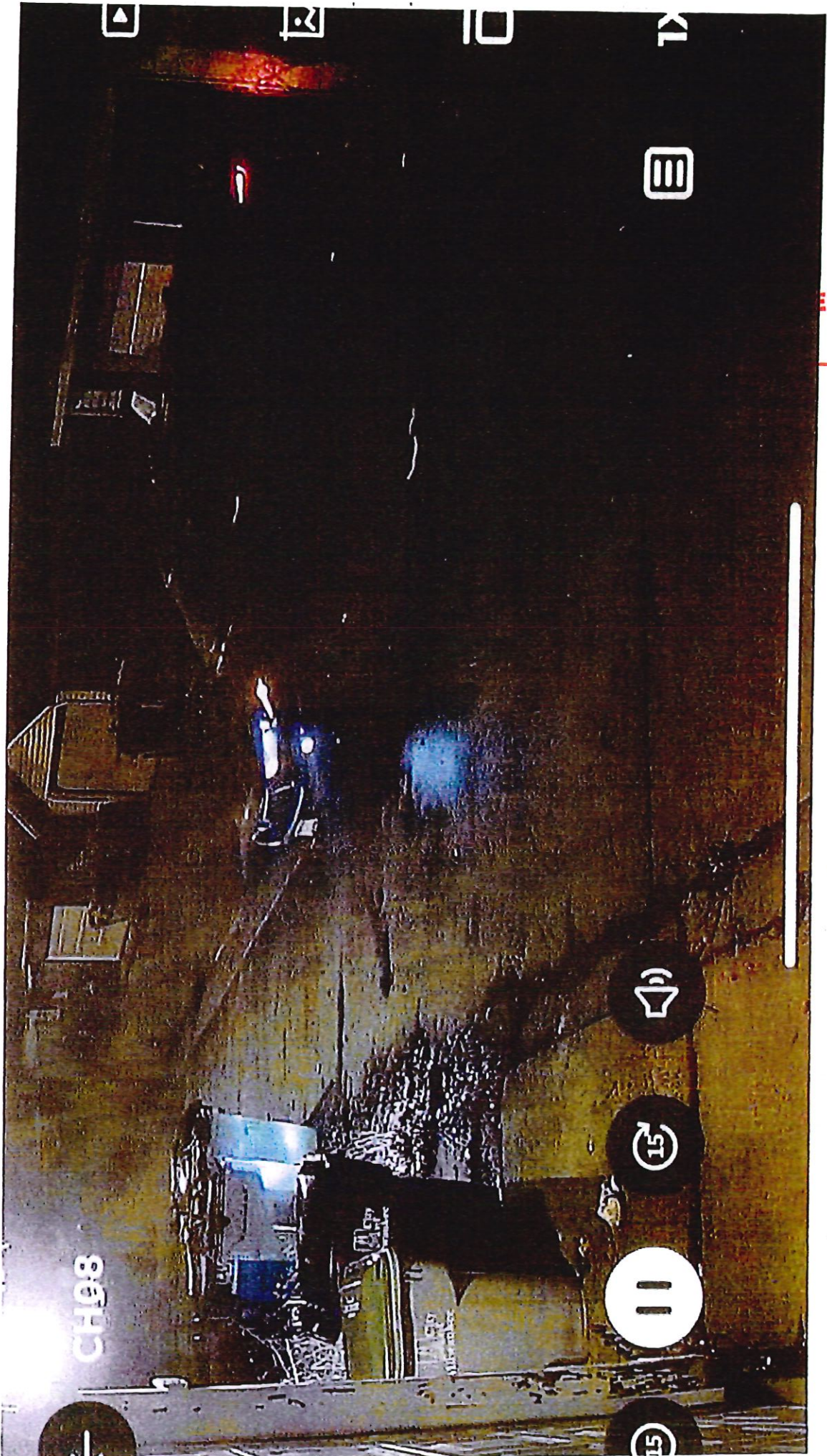

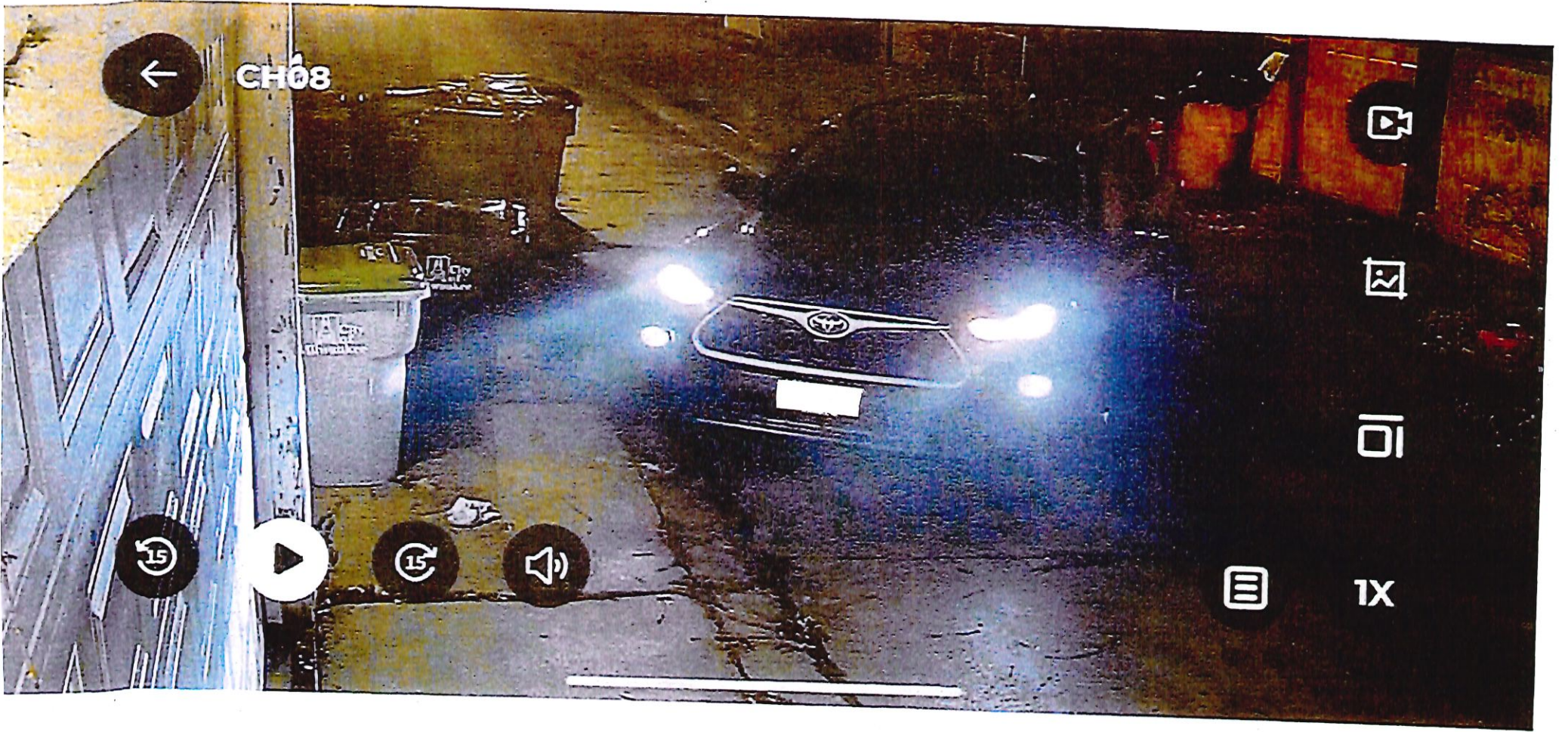

The Milwaukee Police Department's investigation regarding this application revealed the following:

The listed items are related to the licensee and Scrap America located at 3232 W. Fond Du Lac Ave.

1. On 03/06/24, the corporation Scrap America LLC. was issued a Building Code Violation citation, which is still Active with an outstanding balance of \$600.00. Case 24024458.
2. On 08/11/25, at 3:00 p.m., Milwaukee Police received a Theft (by fraud) complaint. The caller reported two vehicles financed through their company tracked to the business. An employee confirmed the vehicles were towed to the business and was attempting to charge the caller \$5,069.00 for storage and tow fees. The applicant stated they would work with the caller to resolve the issues.
3. On 01/20/26, at 12:25 p.m., Officers conducted a Business check of the property. Two reported stolen vehicles and two vehicles with open liens were located and recovered at the business.

This report is written by PO Jamie RODENKIRCH.

On August 11, 2025 we responded to a Theft call for service at the address of 3232 W Fond Du Lac Ave in the City and county of Milwaukee, W,I Scrap America.

Upon arrival we met with the caller James NEWSON (b/m, 01/10/1977) who stated that he was the owner of Square Deal Auto Sales and that he tracked two of his financed vehicles at Scrap America. NEWSON stated that he tracked his 2019 Ford Escape, 1MFC49GD5KUA25658 and 2016 Ford Focus 1FADPSF29GL399738 by GPS. NEWSON stated that he believed he was a victim of fraud due to the vehicle being towed and stored at Scrap America and him not being notified as the legal lien holder. NEWSON stated that Scrap America was charging him \$5,069 for towing and storage fees for the two vehicles prior to Scrap America releasing them to him.

I also spoke to the business representative, Abedalqader SANDOQA (w/m, 04-26-1990) who stated he handles the paperwork for the business. SANDOQA stated that he had records for both vehicles along with NMVTIS (National Motor Vehicle Title Information System) which reports to the WI Department of Justice. SANDOQA stated that the system alerts his tow truck drivers if the vehicle they area towing is reported stolen or if the vehicle has a lien holder. SANDOQA showed me a time stamped National Lien/Theft Report from NMVTIS. Both reports revealed that neither vehicle was reported stolen nor did it display a lien holder. It should be noted that a check of the WI DMV revealed that both vehicles were under a lien through NEWSON's business. SANDOQA showed us towing records and invoices for both vehicles.

ABUHAZIM stated that he would however work with NEWSON to give him a check for the blue book value of the vehicles if he gets an appraisal declaring the vehicles to be totaled.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
