Pursuant to the provisions of Sec. 893.80(1)(a) the claimant, Tracy O. Badger Jr., and adult, residing at 5239 N. Teutonia Avenue, in the City and County of Milwaukee, State of Wisconsin, herewith gives notice of injury giving rise to a future claim for relief in the form of monetary damages as set forth below:

- 1. The attorneys for Tracy O. Badger Jr., an adult resident of the City of Milwaukee, residing at 8522 W. Lancaster Avenue, are Gendlin, Liverman, and Rymer S.C., 10335 W. Oklahoma Ave., Suite 300, Milwaukee, Wisconsin 53227.
- 2. That Tracy O. Badger Jr. sustained serious personal injuries at approximately 1:50 p.m. on January 23, 2014, at 27<sup>th</sup> Street North and Hope Avenue North, in the City and County of Milwaukee, when a 2004 CCC Utility Truck body style GG, operated by Jacqueline Sykes rear ended the vehicle Mr. Badge was operating, and that Jacqueline Sykes was negligent in causing the truck she was operating to strike the rear of the vehicle operated by Tracy O. Badger Jr.
- 3. That Jacqueline Sykes was believed to be an employee of the City of Milwaukee at the time of the collision.
- 4. That a proximate cause of said injuries was the negligence of the City of Milwaukee and Jacqueline Sykes causing serious injuries.
- 5. That as a result of the afore stated incident, Tracy O. Badger Jr. sustained serious personal injuries, pain, suffering and disability, incurred medical expenses, and property damage to the 2014 Chevrolet Sonic LS he was operating.
