
Dear Mr. Chambers:


This office is receipt of your claim in the amount of \$504.94, relating to damages sustained to your vehicle when your vehicle allegedly struck the median island at the intersection of North 12<sup>th</sup> Street and West Burleigh Street on December 25, 2001.

The Infrastructure Division records indicate they conducted no sign maintenance in that time period on the median island at this intersection. In addition, the island was found to be in good order when a site investigation was completed on or about February 26, 2002. As such, the City cannot accept liable for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
