1. Description of Grant Project/Program (Include Target Locations and Populations):

The purpose of this grant is to fund overtime expenses for six officers assigned to the Milwaukee Area Violent Crime Task Force whose purpose is to identify and target for prosecution criminal enterprise groups and/or individuals responsible for crimes of violence and to focus on the apprehension of dangerous fugitives where there may be a federal investigative interest. This task force also enhances the effectiveness of other law enforcement resources through an initiative seeking the most effective investigative/prosecutable avenues to convict and incarcerate dangerous offenders.

2. Relationship to City-wide Strategic Goals and Departmental Objectives:

This resolution is consistent with the mission and vision of the Milwaukee Police Department to reduce crime, fear, and disorder through problem-oriented and data-driven policing. The Milwaukee Area Violent Crime Task Force will work closely with other law enforcement agencies to enhance the overall effectiveness of law enforcement resources to reduce crime and disorder by working collectively. A small group of violent crime offenders in small geographic spaces are often responsible for a large number of crime and disorder throughout different neighborhoods. By focusing on the most prolific violent crime groups and/or individuals, this can have an impact city-wide which creates safe living environments for all neighborhoods.
