AFFIDAVIT and CLAIM

I, Jack (John) R. Pettigrew, the undersigned, do of my own personal knowledge make the following statements and declare them to be true.

On 1-18-1998, my son John R Pettigrew (DOB: 3-13-1967), was arrested in the City of Milwaukee for several offenses under Case No.: 98CF980361. He had two of my personal firearms in his possession, which were seized and placed in inventory #52254. That following morning, two MPD detectives went to my residence in Brown Deer and, against my objections, seized my entire personal firearms collection, even though they were in no way related to the above mentioned incident. They stated they were being taken for "safe keeping." These firearms were placed in inventory #52255.

On or about 11-5-1998, after having spent \$450.00 in attorneys fees to get "MY PERSONAL" property returned, they were picked up by my stepson Glen Schott.

Upon my return to Wisconsin in early April, 2000, from my second home in Florida; I had the opportunity to personally inspect my firearms for the first time since they were returned. What I observed shocked me. Items that were taken for "safe keeping" were kept anything but safe. What had formerly been a well-balanced and unique collection of firearms with a significant investment and collectors value were now nothing more than a pile of "shooters grade" firearms with no significant value. At some point after being seized from my residence, and returned to my stepson, several of my firearms were damaged by the use of a mechanical engraving tool to inscribe markings or control numbers into the metal. As described below and shown in the included photographs, these engravings are not only in the finish of the firearms but are actually into the metal. Damages occurred to the following firearms as documented below:

1. Inventory #7. Rifle, AK47/S, 7.62 x 39mm cal., KFS Import (Polytech manufacture), Serial # P47-09037.

As shown in the attached photographs, there are four separate inscriptions of the characters 'CR98-362-RHT' on this rifle. The first photo shows one on the receiver and a second on the bolt cover of the rifle. The second photo shows an inscription on the gas port. The third photograph shows an inscription on the front portion of the barrel. All inscriptions are clearly visible.

2. Inventory #9. Rifle, Mini14-Stainless Steel, .223 cal., Strum Ruger manufacture, Serial #181-85754.

As shown in the attached photographs, there are two inscriptions of 'DR98-362-RHT' on this rifle. The first photo shows the inscription on the left side of the receiver below the scope. The second inscription is on the bottom side of the exposed barrel of the rifle.

3. Inventory #5. Rifle, SKS, 7.62 x 39mm cal., Russian (early 1950's rebuilt), Serial #3A2112.

As shown in the attached four photographs, there are five separate inscriptions of 'BR98-362-RHT' on this rifle. The first photo shows an inscription on the left side of the receiver and a second on the bolt. The second photo shows an inscription on the magazine well on the bottom of the rifle. The third photo shows an inscription on the trigger group on the bottom of the rifle. The fourth photo shows an inscription on the barrel of the rifle.

4. Inventory #3. Rifle, A-15, .223 cal., DPMS manufacture, Serial #9429. With attached Grenade Launcher, M203, 40mm, unknown manufacture, Serial #051.

As shown in the following four photographs, there are 5 occurrences of the inscription 'AR98-362-RHT' on these two items. The first photo shows the inscriptions on both the upper and the lower receiver on the left side of the A-15 rifle. The second photo shows an inscription on the bottom side of the barrel of the rifle. The third photo shows an inscription on the left side of the M203. The fourth photo shows an inscription and several deep scratches in the barrel of the M203 at the front bottom side.

5. Inventory #25. Pistol, TZ-75, 9mm. Cal., Fratelli manufacture, Serial #H22976.

As seen in the photograph for this pistol there is an inscription of 'FR98-362-RHT' on the left side of the frame of the pistol immediately above the trigger guard.

All of these firearms were either 'unfired' or in 'like new' condition and were being maintained for their collector and investment value. They were all considered to be in a 'pre-ban' configuration in respect to the Federal Assault Weapons Ban of 1994, which further enhanced their collectability due to the fact that these firearms cannot be manufactured anymore.

To any serious collector, these firearms have no value regardless of any amount of repair and refinishing that could be done, which in some circumstances would even make the firearm dangerous to use (should one decide); due to the amount of metal that would have to be ground down to remove the etchings. Therefore, I've collected values that are representative of the current market value of the same (or as similar as possible) to the damaged firearms. Included at the end of this document are the values I've acquired and my claim is based upon an average of these values. Upon adequate reimbursement to restore my collection, I will have no problem returning my damaged firearms to the City for whatever use they may have for them.

As itemized in the above table, I have calculated a claim amount of \$7250 which is being more than fair to the City taking into account that I have only included the cost of the parts for the M203 rather than the completed item. This reduces the claim by approximately \$1200. Therefore, I am requesting relief for damages in the amount of \$7250. I trust this matter can be adequately resolved to the satisfaction of both the City and myself.
