To whom it may concern:

I am writing to support the application to rename the park on 20th & Olive in honor of William Gore.

William Ira Gore was born on July 30, 1933 to the union of Frances Janerette and William Ira Gore, Sr. in Conway, South Carolina. William received his formal education from Booker T. Washington High School in Columbia South Carolina. He later earned a bachelor of science from Morehouse College in 1954, enlisted in the United States Army and was honorably discharged in July, 1956. He would later earn a Master's in social work (MSW) from Atlanta University School of Social Work.

Throughout most of his life, William Gore was employed by Milwaukee County. In 1988, he retired from the Milwaukee County Mental Health Complex as Director of Psychiatric Social Services. At the time of his retirement an ad was placed by his colleagues at the County with the headlines, "Who Said There Are No Heroes Anymore?" It is often said that he had a significant impact on the City of Milwaukee. As a member of the Fire and Police Commission and Chairman for nine of his fifteen year tenure from 1973 to 1988. Frequently firefighters and police officers, particularly African Americans, shared their personal stories about the influence he had on their lives. As a 33rd Degree Prince Hall Mason, he interacted with countless individuals that acknowledged his willingness to share his wisdom and encouragement. As Director and Vice Chairman of Columbia Savings and Loan, Gore worked diligently to provide oversight for the oldest African American financial institution in the city of Milwaukee. In addition to his love for family and community, William Gore loved his home! Located at 4209 North 19th Place, Gore dutifully took care of his home and the block he lived on for many decades. He raised his family, developed lifelong friendships and recognized the value of a safe place to live. Gore was seen on a daily basis making sure that the streets and tot lot behind his home remained clean and safe for others. He took great pride in the neighborhood.

It is with great pleasure that the Gore family participate in the application to identify the tot lot between 19th place and 20th street as an honorary naming opportunity for William I. Gore
