This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/22/2019 at 12:35am officers investigated a battery complaint that occurred outside Skybox Sports Bar, 2213 N. Martin Luther King Jr Dr. The victim stated she was with a group inside the bar and another group was inside singing karaoke. There was tension between the groups and security asked both groups to leave. Outside a fight occurred and the victim was pepper sprayed. The officers spoke with the owner Royce LOCKETT, who stated he observed the tension between the groups and had security escort them out. Outside he had security attempt to break up the fight when an unknown actor pepper sprayed the whole fight. The officers viewed the surveillance video, which confirmed security attempted to break up the fight.
2. On 06/10/2019 officers conducted a licensed premise check at Skybox Sports Bar, 2213 N. Martin Luther King Jr Dr. The officers spoke with Royce LOCKETT, part owner of the bar. The officers advised LOCKETT about parking problems outside at night. LOCKETT stated on his busy nights he makes announcements to his patrons about the parking and the officers should cite the violators.
3. On 08/24/2019 at 1:30am officers observed 60-70 people fighting in the 2200 block of N. Martin Luther King Jr Dr. The officers also heard several gun shots in the area. The only business open at this time is Sky Box Sports Bar, 2213 N. Martin Luther King Jr Dr. The officers called for assistance and the street was blocked to traffic. The fight was broken up and additional fights occurred around the corner. The officers used pepper spray to break up the fights and get the subjects to leave. The officer spoke with Royce LOCKETT, manager at

Sky Box Sports Bar. He stated there was a party that night and there was a large group causing a problem. He stated at about 1:20am his security kicked out half of the subjects. At 1:30 the other half was kicked out and a fight broke out down the block.

4. On 12/11/2019 officers conducted a license premise check at Skybox Sports Bar, 2213 N. Martin Luther King Jr Dr. The officer spoke with the manager about their plans for New Year's Eve. The manager stated they would be open until 3:00am and would have additional security on hand, both inside and outside. The officer advised the manager to call if there were any problems.
5. On 05/01/2020 at 10:54pm officers conducted a license premise check at Skybox Sports Bar, 2213 N. Martin Luther King Jr Dr. The officers were conducting follow up regarding an email from the alderman about a possible Stay at Home order violation. The officers spoke with the manager, who stated he has been open for carry out and he believes the complaint comes from an Uber driver, who was upset because he made him wait in line. He stated he has been practicing social distancing and limiting the number of people inside to get food. The manager stated he does not want any problems and will follow until they are lifted.
6. On 07/05/2020 at 12:54am officers were dispatched to a Subject with gun at 2213 N. Martin Luther King Jr Dr. The caller stated there were 3-4 subjects outside the bar attempting to fight an employee. When the officers arrived they observed 100-125 people outside the bar. A subject stated there was a female at the front of the bar that needed to be removed. Due to the number of people outside it was not safe for the officers to engage the crowd. The officers could not locate the subject that was described as having a gun. At 1:30am the officers were called back to the bar. The caller stated there were now only 3-4 people outside and they had guns. When the officers arrived they spoke with the manager, Royce LOCKETT, who stated there was a female that was kicked out of the bar that was upset with security. She was threatening staff and would not leave. He believed she called people to the scene with guns. The officers walked the security guard to his car and he left without incident.
7. On 10/11/2020 at 9:35pm officers, on routine patrol, observed a large crowd standing in line at Skybox Sports Bar. They also observed numerous illegally parked cars. They began issuing parking citations and at 10:06pm heard the DJ inside announce the bar was closing. A large group of people exited the bar and a fight started near the tavern. There were approximately 200 people outside the tavern and the officers called for additional squads to block traffic to protect the patrons standing in the roadway. The officers had to use O.C. spray to break up the fight and the officer arrested 3 subject who were fighting. The officers spoke with the applicant and her husband, Royce LOCKETT. LOCKETT stated the normal capacity is 300-350 and tonight they were at 173. He had 7 security officers working and they were attempting to throw out a disorderly patron. The patron's friends became involved in a fight so he closed the bar. The applicant stated they have been using reflective cones to block no parking zones, but patrons sometimes move them.
8. On 11/23/2020 at 9:13pm officers conducted a license premise check at Skybox Sports Bar, 2213 N. Martin Luther King Jr Dr. The officer spoke with the manager, Royce LOCKETT, about his plans for New Year's Eve. He stated he was recently cited by the Health Department for Covid related violations and he is unsure if he would be open. He stated if he was open he would close early and comply with his health plan on file.

9. On 01/29/2021 at 3:38pm officers conducted a license premise check at Skybox Sports Bar, 2213 N. Martin Luther King Jr Dr. When the officers entered they heard loud music coming from the basement. They went downstairs and found a private party being held. Janay ALSTON, who identified herself as the general manager, was advised the business licenses had expired on 01/20/2021. ALSTON stated she was told by Royce LOCKETT that the licenses were up to date. The officers then talked to LOCKETT, who stated he thought Alderwoman COGGS had approved a provisional license. LOCKETT was advised to cease operations until he has been issued a license.
10. On 02/03/2021 at 11:03pm officers conducted a license premise check at Skybox Sports Bar, 2213 N. Martin Luther King Jr Dr. The officers had knowledge the bar's license expired on 01/20/2021 and did not have a current license. The officers spoke with the business manager, Royce Lockett, who stated he was attempting to get a Provisional Renewal. He stated he spoke with License Division by phone and was told he was good to be open. The officer checked LIRA and found no Provisional License issued. On 02/04/2021 the officers checked the bar and found it closed.
11. On 02/28/2021 at 9:28pm officers were dispatched to a Trouble with Subject at Skybox Sports Lounge, 2213 N. Martin Luther King Jr Dr. The caller stated the bar was over capacity and the patrons were not wearing face masks. The officer spoke with security at the door, who stated their capacity is 276 and they were currently at 265 patrons. The officers observed the patrons standing shoulder to shoulder, not wearing masks. The security guard had a mask but it was not covering his face while in contact with patrons. The officer spoke with the manager, Royce LOCKETT, who stated the bar was closing shortly.
12. On 02/28/2021 at 11:01pm officers were dispatched to a fight at 2213 N. Martin Luther King Jr Dr. The officers spoke with a security guard, who stated multiple patrons left the bar and were fighting in the street. He stated that shortly after the fight he heard gunshots in the area. He did not see who was shooting. The officers did not locate any casings or other evidence of the shots fired.
13. On 03/01/2021 at 5:37pm officers conducted a license premise check at Skybox Sports Lounge, 2213 N. Martin Luther King Jr Dr. The officers spoke with the manager, Royce LOCKETT, about the overcapacity call and a fight call from the prior night. LOCKETT stated he was on scene and spoke with the officers about the capacity call and they did not believe the bar was overcapacity. LOCKETT stated about 30 minutes after the police left a fight began and the police responded back. The officer advised LOCKETT he had received two cell phone videos of the fight inside and outside the bar. The officer stated a major concern from the video was security officer with AR15 style rifles attempting to disburse the crowd. The officer then watched the videos with LOCKETT. The video shows a large group fighting inside and table being thrown. The bar is closed and the patrons move to the front entrance. The second video shows a fight outside with security guards attempting to break up the fight. LOCKETT stated the security guards with the guns were not his but were from the parking lot across the street. LOCKETT stated his security was inside because he did not want them going outside when he was having issues inside. The officer spoke with the applicant by phone and she stated she planned to hire new security in the immediate future.
14. On 03/02/2021 at 11:30am an officer received a call from the applicant regarding Skybox, 2213 N. Martin Luther King Jr Dr. The applicant wanted to advise the Community Liaison Officer of the changes planned for the upcoming weekend. She advised the security team she previously employed was fired and she was hiring a new company that she hoped to have in place by this weekend. She also planned to increase security on Sunday nights, with more

people at the door. She also is advising security that it is their responsibility to enforce the mask mandate and all other Covid-19 regulations. She inquired about getting restraining orders for problem patrons and how to keep records on subject banned from the bar. The officer suggested a binder at the front door with copies of subject's ID's.

15. On 03/02/2021 at 7:21pm officers went to Skybox Sports Bar at 2213 N. Martin Luther King Jr Dr in an attempt to recover video from the 02/28/2021 incidents. The officers were met by the manager, Royce LOCKETT, who allowed the officers to access the DVR. The officers were able to locate and transfer the videos to a thumb drive. The video from the interior shows a fight start on the patio and come inside. The subjects are escorted out the front of the building and a fight occurs outside, which security attempts to break up. The video also shows a subject going to his truck to get a pistol and stand outside the business. A second subject is also seen with a gun outside. While this is going on employees of Skybox are observed going in the basement and coming back up with AR style rifles. Security is then standing at the front door watching the fight while holding the rifles. The fight outside continues and two more security guards working outside come up with rifles and attempt to break up the fight outside. After the fight is broken up the street was clogged with traffic and a gunshot is heard. Patrons were observed running and ducking for cover. Police officers then arrived on scene. During the incident security did not point their firearms at anyone, they appeared to be protecting the bar.
16. On 03/04/2021 officers went to Sky Box Sports Bar, 2213 N. Martin Luther King Jr Dr to speak with the manager, Royce LOCKETT, regarding the fight from 02/28/2021. The officers advised LOCKETT that a victim came into the station on 03/04/21 to report a substantial battery that occurred on 02/28/2021 at Sky Box. The female stated she got into a fight over Hookah with another female. The suspect hit her in the head with a bottle, causing a laceration that required stitches to close. The victim had video of the incident that was posted on social media. LOCKETT stated he has fired his security company and is looking to hire a new company. The officers became aware there was another complaint, filed by a different victim, of being hit in the head by a bottle on 02/28/2021. The victim went St Joseph's Hospital and notified police from the hospital. This incident started inside with an argument about Hookah and escalated outside, where the victim was hit with a bottle. This victim received 4 staples to the back of her head.

## Narrative (1)

### LICENSE PREMISE REPORT

This license premise report is submitted by PO David LETTEER, assigned to District 5 Late Power Shift, Sq. 5468 with PO Russell MACRAE.

On 03-04-21 at 11:00 p.m., PO MACRAE and I went to Sky Box Sports Bar, located at 2213 N. Martin L. King Jr. Dr., to speak to the Class B Manager, Royce LOCKETT, in regards to the videos we watched from the night of 02-28-21. We also informed LOCKETT that a female had come into District 5, on 03-04-21 at 4:40 p.m., to report a substantial battery, which occurred at Sky Box on 02-28-21. The female was identified as Casalena M. THOMAS. The report was taken by the early shift Acting Desk Sergeant.

THOMAS stated that she had gone to the location on February 28th, 2021, at approximately 10:30PM with a friend she identified as "Yomma NICOLE". THOMAS stated that they entered the bar and got a table near the front door equipped with a 'hookah' smoking pipe. THOMAS stated that they also purchased a bottle of "Patron" liquor, which was at the table with them. THOMAS stated that shortly afterwards an unknown black female subject wearing blue jeans and a white top approached the table and told them it was her hookah. THOMAS stated she told the subject that it was THOMAS's table and hookah, and the subject was mistaken. THOMAS stated that the subject then picked up the bottle off the table and swung it back as if to strike 'Yomma'. THOMAS stated that 'Yomma' grabbed one of the subject's hands and THOMAS attempted to push the subject away from them. THOMAS stated that the subject swung the bottle, striking THOMAS in the forehead, and then grabbed her by the hair.

THOMAS was asked if she had any documentation from either hospital. THOMAS stated she did not have any with her at the time. THOMAS had two videos on her phone which she stated were posted on Instagram and Facebook and which showed portions of the incident. The first video THOMAS showed was a group of people including THOMAS and a black female. THOMAS pointed out as the subject that hit her. Numerous people are visible fighting each other and holding THOMAS, the female subject and others apart. Blood is clearly visible on THOMAS' head and face. The video does not show THOMAS being struck.

THOMAS showed another video which showed the outside of the bar. THOMAS pointed out a female subject wearing a white top and blue jeans fighting outside of the bar. THOMAS stated that it was the same subject that struck THOMAS, but THOMAS stated she was not involved in the incident in the video as it occurred after THOMAS had left for the hospital.

THOMAS had a large laceration in the center portion of her forehead which had been closed by 12 stitches and was swollen. THOMAS complained of headache pain throughout the interview.

I (PO LETTEER) did watch the videos and I did observe a black female walking in the bar who

had taken off her white shirt, walking around in a black bra, holding the white shirt to her head, to help control bleeding. THOMAS was also observed on an outside camera exiting the bar, still holding the shirt to her head with blood on it. THOMAS was not observed after this.

We informed LOCKETT of this and he stated that he was in contact with a female, possibly THOMAS and that they were discussing the situation.

PO MACRAE and I then also informed LOCKETT of the two individuals who we observed outside of the bar, on the exterior camera with firearms waiting outside of the bar. LOCKETT did not know this and stated that he had fired his security company Carlos SINGLETON, head of his security and his team. LOCKETT stated he was in the process of looking at 3 reputable, insured security companies to conduct security at the bar. LOCKETT stated that the city had informed him that the bar can only have 25% capacity from now on and that he had a meeting with the licensing committee on 03-09-21.

We informed LOCKETT that we would have to file this report because the incident happened inside of his establishment.

PO MACRAE and I left the bar and shortly after we were informed by the Late Shift Desk Sergeant that there was another person who was hurt as a result of the fight (IR 21-060-0007).

On 03-01-21 at 12:21 a.m., squads were sent St. Joseph's Hospital for a battery cutting. Upon arrival officers spoke to Yasmine A FERGUSON. FERGUSON stated she was at Skybox located at 2213 N Martin Luther King Dr. celebrating. At approximately 11:00pm, she got into a verbal altercation with about 15 other unknown females regarding the use of a hookah that FERGUSON claims to have purchased. One of the unknown females stated she was the one that purchased the hookah and wanted to smoke from it. FERGUSON told the female that she couldn't because she didn't pay for it. FERGUSON then exchanged heated words with the unknown females. Then an unknown female went to hit FERGUSON with a bottle, however, one of FERGUSON's friends blocked the attempt. FERGUSON and her friends then went to leave. FERGUSON was struck once in the face with a bottle, resulting in a contusion to her right eyebrow.

Upon leaving Skybox, FERGUSON and her friends were walking to the car when some of the unknown females pulled up in a car and continued the verbal altercation. The unknown females exited the vehicle and threw a bottle at FERGUSON, striking FERGUSON in the back of the head. The resulting laceration to the back of FERGUSON's head required 4 staples to close.

On Sunday, February 28, 2021 at 11:01 PM, Squad 5436 (P.O. Tyler SEELOW and I) was dispatched to a fight complaint at 2213 N. Dr Martin Luther King Jr. Dr. in the City and County of Milwaukee. My partner and I were both wearing body worn cameras, full duty uniform and driving a marked squad car.

Squad 5436 was dispatched to a complaint from Bell Ambulance who stated that a fight was occurring in the street outside of Skybox Sports bar. It should be noted that this was the second time squads were dispatched to Skybox Sports Bar on the same night. Squads 5436, 5426, 5230, 5240, 5412, 953, 5438, and 5448 responded to this incident due to the amount of people in the bar and the nature of the call. It is also important to note that this call came in after security stated they would be shutting the bar down do to the large amount of people inside. Upon arrival I spoke with the Security Guard who was identified as Carlos J SINGLETON (B/M 1/6/1994). SINGLETON stated that before we arrived multiple subjects were fighting in the street. SINGLETON stated they were patrons that had recently left the bar. SINGLETON stated the subjects were on the corner of N. MLK Drive and W. Garfield Ave. SINGLETON stated that the subjects then entered cars and continued arguing. SINGLETON stated that shortly after the fight, he heard gunshots from the area of N. MLK Drive and W. Garfield Ave. SINGLETON stated he did not see who was shooting but believed the subjects were firing into the air. We searched the area for any injured people that may have been struck by gunfire but did not locate any. We did not locate any casings or any other signs of a gunfight. No buildings or vehicles appeared to be struck by gunfire.

On 03-02-21 at 7:27 p.m., we went to the location of 2213 N. Martin L. King Jr. Dr., Skybox Sports Bar, which is a licensed premise in the City of Milwaukee. We were advised that we needed to retrieve video from two incidents that occurred on 02-28-21, a fight and a COVID violation.

Upon arrival at Skybox, we were met by the manager of the establishment, Royce LOCKETT. I informed him that we were instructed to gather the videos from the incidents that occurred on 02-28-21. LOCKETT stated he would let us get the videos and escorted us to the basement, where he keeps his DVR recorder.

PO MACRAE was able to use the DVR, locate the date and time, as well as the videos. The videos were able to be saved to a thumb drive. Upon saving the videos, we returned to District 5 and we were able to view the videos.

I have included a narrative of watching the videos and they are as follows. The videos I have included with this report are labeled as such, with the same video names on the disk:

### VIDEO FOOTAGE:

**"Interior COVID Video"** shows all the patrons in the bar, standing, drinking and talking with each other. The video shows from the bar to the front of the bar. As the video plays, at 1:26:23 mark shows the patio door open and several people begin to fight in the patio area. As the video continues, the people fighting come inside of the bar and are eventually escorted out the front door.

**"Exterior Front-Door Video"** shows a fight in front of the bar at the 42:00 minute mark, a group of females begins to fight outside and security attempts to break it up. While the females are fighting a black male goes to a Dodge Ram across the street and retrieves a black semi-automatic handgun with an extended magazine, walks back across the street

and stands outside the front of the business, in what appears to be waiting for someone. The black male, wearing black pants, black hoodie with a hood and a white design on the left breast, with black twisties, continues to wait. He has the gun in his right hand and appears to hold the gun and put it in his right hoodie pocket several times. While waiting, there is a black male with a tan jacket with tan fur around the neck, who also is carrying a handgun, which is later concealed in his jacket. He continues to walk around the front of the bar, with his right hand in his jacket, reaching to the left side of his jacket. He too appears to be waiting for someone to exit the bar.

After a few minutes, the black male wearing the hoodie, enters a black Dodge Ram pickup truck and leaves the area. At the 57:00 mark of the video, a group of females is waiting across the street from the bar, they are waiting to fight other females who appear in front of the bar. While this is going on, there are (2) employees of Skybox Security holding AR-15 style rifles watching the fight. There is also another employee of the security holding an AR-15 style rifle, all now standing at the front door.

The female fight continues in the middle of the street in front of Skybox, (2) more black males who are doing security for a parking lot, just north of 2218 N. MLK appear holding AR15 style rifles and run from across the street to the front of Skybox, who appear to try to protect Skybox. These individuals appear to attempt to break up the fight between the females while holding their rifles in their hands. Eventually the (2) males who ran across the street from the parking lot, run back to the lot and leave the fight.

After the fight is broken up, N Martin L. King Jr. Dr., is clogged with cars and traffic is backed up. As people are still leaving, a gunshot is fired from an unknown direction or location, which causes the remaining people to duck and run from in front of the bar inside, as well away from the bar. Squads eventually appear for a call for a fight at the location of the Skybox. The video ends and shows one of the Skybox security leaving with what appears to be a gun bag at the end of his shift.

"**Interior Front Door Video**" shows the camera that watches the entrance front door from the interior. The video plays and shows that security does escort several females out of the bar and people then begin to leave out of the bar via the front entrance. At the 8:30 mark of the video, shows a security person wearing a Skybox shirt goes downstairs and comes back up with an AR15 style rifle and what appears to be an AK-47 style pistol. The male wearing the Skybox shirt, hands Carlo (Skybox Head-Security Person) the AK-47 pistol. Carlos appears to seat the magazine in the weapon and is carrying the weapon. After this happens, another male wearing a red shirt, with a black walkie talkie (security) is standing with a handgun out, being carried in his hand, behind his back near

the front entrance to Skybox. These weapons that security were in possession of were never raised or pointed at anyone. It appears that they were protecting the bar. As people are being escorted out of the bar, you see LOCKETT standing near Carlos, helping get people out of the bar. **\*\*\* It should be noted that Carlos was carrying a pistol in a shoulder-holster the entire night as well \*\*\***

Continuing to watch the video, at the 18:30 mark, people are inside of the bar, the lights are turned off and the people in the bar are kept in the bar, watching what is going on outside, possibly the fight. After a few minutes the people inside of the bar leave and the bar staff begin to clean the inside of the bar.

We informed LOCKETT that we would file this report. At 9:40 p.m. (03-02-21) PO MACRAE attempted to contact the licensed agent, Lisa TOI-MARK of our interaction with the bar tonight, but the call went to voicemail and unable to leave any message.

On 03/01/21 at 05:37pm, PO David LETTEER and I (SQ#5468) conducted a Tavern Check at "SKY BOX SPORTS BAR" located at 2213 N Martin L King Jr Drive. Our check was in regards to (2) calls for service the previous night at the bar regarding over-capacity, and a large fight.

Upon arrival, we made contact with the bar manager identified as Royce LOCKETT. We informed LOCKETT that we were there regarding the calls for service the night before (02/28/2021) and that I was sent cell phone videos of it. LOCKETT stated separate groups inside the bar had become engaged in a fight inside. LOCKETT stated that once they were outside, the parties involved began to call more people to the bar to fight.

LOCKETT stated that police responded to the bar earlier in the night (02/28/2021) and stated that they (MPD) had received a call that the bar was over-capacity. LOCKETT stated that the officers told him that they did not suspect the bar to be over-capacity, however they would be following up with the Tavern Car the next day. LOCKETT stated that approximately 30mins later, the large fight began and the police had to respond back to the bar.

I informed LOCKETT that I had received cell-phone video of the fight inside the bar, and a fight outside the bar. I proceeded to play the videos for LOCKETT. The first video shows a very large crowd on

The video shows a large group begin to fight and a female who was actively bleeding from her head. The woman then takes her shirt off to attempt to stop the bleeding. Patrons were now standing on tables/chairs and you can hear security tell patrons to leave. Both men and women begin to actively fight. Tables begin to be thrown as well as Hookah smoking equipment. Eventually the interior lights turn on, the DJ tells everyone to leave, and patrons begin to slowly move towards the front entrance.

I then showed LOCKETT the second video. The video shows (5-6) women outside the bar in the street beginning to fight. The women were punching each other and pulling hair. The group moves towards the front entrance to Sky Box however it is clear that the door is locked and they cannot enter. During the video there are numerous people cheering the fight on and glass bottles are thrown in the direction of the fight. At that time, a B/M wearing a black "Security" sweatshirt and hat walk immediately up to the fight and attempted to break the fight up. The unknown security person is also armed with an AR15 style rifle and was holding it in his hands. The fight continues and moves back into the middle of MLK Drive. Another B/M with a grey jacket appears in the video who had walked from the area across the street from Sky Box. The subject was holding an assault rifle and it was "slung" across his chest. At that moment the sound of police sirens enroute to the location is heard. The video then ends.

LOCKETT stated that he was at the front door at the time of the second video. LOCKETT stated that he and his staff/security were inside the bar at all times. LOCKETT did not want them to go outside to break up another fight when there was already issues inside. I pointed to the man with the "Security" sweatshirt/hat on and asked if he was one of LOCKETT's security. LOCKETT stated no, and that his security wears "Sky Box" uniforms were security on it and not what that subject was wearing. LOCKETT stated that he is positive that those armed subjects are the security from the parking lot located just north of (2218 N MLK Drive) across the street. LOCKETT stated that those security will come as assist his staff from time to time.

I informed LOCKETT that due to PO LETTEER and I not working and not being present at the time of the fights we wanted to come in and speak with him regarding. I informed LOCKETT that a large bar is bound to have fights, and it appeared that his staff did as best as they were able to handle to large situation. LOCKETT stated that he was concerned that if they were outside to assist to break the fight up, that his staff may become injured from others who were showing up after the fact. On 03/01/21 at 05:37pm, PO David LETTEER and I (SQ#5468) conducted a Tavern Check at "SKY BOX SPORTS BAR" located at 2213 N Martin L King Jr Drive. Our check was in regards to (2) calls for service the previous night at the bar regarding over-capacity, and a large fight.

Upon arrival, we made contact with the bar manager identified as Royce LOCKETT. We informed LOCKETT that we were there regarding the calls for service the night before (02/28/2021) and that I was sent cell phone videos of it. LOCKETT stated separate groups inside the bar had become engaged in a fight inside. LOCKETT stated that once they were outside, the parties involved began to call more people to the bar to fight.

LOCKETT stated that police responded to the bar earlier in the night (02/28/2021) and stated that they (MPD) had received a call that the bar was over-capacity. LOCKETT stated that the officers told him that they did not suspect the bar to be over-capacity, however they would be following up with the Tavern Car the next day. LOCKETT stated that approximately 30mins later, the large fight began and the police had to respond back to the bar.

I informed LOCKETT that I had received cell-phone video of the fight inside the bar, and a fight outside the bar. I stated that the largest issue we had was that security was observed in the video outside the bar with AR15 style rifles while attempting to disperse the crowd. I asked LOCKETT if he still had the same hired security that he has had. LOCKETT stated that he is now looking to get new hired security after the large fight. LOCKETT stated that he had not seen the videos yet, but had heard that there were videos online regarding.

I proceeded to play the videos for LOCKETT. The first video shows a very large crowd on

the 1st floor of Sky Box. The patrons were shoulder-to-shoulder and not social distancing. It appeared that little to none were also wearing face-masks. The video shows a large group begin to fight and a female who was actively bleeding from her head. The woman then takes her shirt off to attempt to stop the bleeding. Patrons were now standing on tables/chairs and you can hear security tell patrons to leave. Both men and women begin to actively fight. Tables begin to be thrown as well as Hookah smoking equipment. Eventually the interior lights turn on, the DJ tells everyone to leave, and patrons begin to slowly move towards the front entrance.

I then showed LOCKETT the second video. The video shows (5-6) women outside the bar in the street beginning to fight. The women were punching each other and pulling hair. The group moves towards the front entrance to Sky Box however it is clear that the door is locked and they cannot enter. During the video there are numerous people cheering the fight on and glass bottles are thrown in the direction of the fight. At that time, a B/M wearing a black "Security" sweatshirt and hat walk immediately up to the fight and attempted to break the fight up. The unknown security person is also armed with an AR15 style rifle and was holding it in his hands. The fight continues and moves back into the middle of MLK Drive. Another B/M with a grey jacket appears in the video who had walked from the area across the street from Sky Box. The subject was holding an assault rifle and it was "slung" across his chest. At that moment the sound of police sirens enroute to the location is heard. The video then ends.

LOCKETT stated that he was at the front door at the time of the second video. LOCKETT stated that he and his staff/security were inside the bar at all times. LOCKETT did not want them to go outside to break up another fight when there was already issues inside. I pointed to the man with the "Security" sweatshirt/hat on and asked if he was one of LOCKETT's security. LOCKETT stated no, and that his security wears "Sky Box" uniforms were security on it and not what that subject was wearing. LOCKETT stated that he is positive that those armed subjects are the security from the parking lot located just north of (2218 N MLK Drive) across the street. LOCKETT stated that those security will come as assist his staff from time to time.

I informed LOCKETT that due to PO LETTEER and I not working and not being present at the time of the fights we wanted to come in and speak with him regarding. I informed LOCKETT that a large bar is bound to have fights, and it appeared that his staff did as best as they were able to handle to large situation. LOCKETT stated that he was concerned that if they were outside to assist to break the fight up, that his staff may become injured from others who were showing up after the fact. I informed him that there would be

MARK also reiterated that they (Skybox) planned to hire new security staff in the immediate near future.

The owner identified herself as Toilisa MARK. MARK stated that she wanted to touch base with the Community Liaison Office regarding the incidents that occurred at her business the night of Sunday, February 28, 2021. MARK stated that she had a constructive conversation with Tavern Squad (Squad 5468 PO MACRAE and PO LETTEER) last night (License Premise Report 210600138) and wanted to follow up with our office to express the up coming changes she will be implementing this coming weekend.

MARK stated that the current security team, All Around Protection, will no longer be employed by them. She believes they made the situation worse rather than resolving any of the issues that were presented Sunday night. She is currently actively looking for a new security team and hopes to have them employed by Friday March 5th, 2021. MARK stated she plans on increasing security on Sundays along with staffing more people at the front door. She plans on increasing the age limit on Sundays. MARK also stated that she will be informing her staff and the security teams that they all are responsible to enforcing the mask mandate and will be abiding my all covid-19 regulations. MARK stated she will be doing an open records requests for the names of the individuals that caused issues Sunday and will be filing restraining orders. MARK inquired on how to keep records of the people they wish to "ban" from their establishment. I advised other stores in the District have a binder with subject's pictures and a copy of their ID available so that employees can recognize those who are banned and can give officer's correct information for future citations. MARK stated that she will be looking into implementing a similar system.

This license premise report is submitted by PO David LETTEER, assigned to District 5 Late Power Shift, Sq. 5468 with PO Russell MACRAE.

On 03-04-21 at 11:00 p.m., PO MACRAE and I went to Sky Box Sports Bar, located at 2213 N. Martin L. King Jr. Dr., to speak to the Class B Manager, Royce LOCKETT, in regards to the videos we watched from the night of 02-28-21. We also informed LOCKETT that a female had come into District 5, on 03-04-21 at 4:40 p.m., to report a substantial battery, which occurred at Sky Box on 02-28-21. The female was identified as Casalena M. THOMAS. The report was taken by the early shift Acting Desk Sergeant.

THOMAS stated that she had gone to the location on February 28th, 2021, at approximately 10:30PM with a friend she identified as "Yomma NICOLE". THOMAS stated that they entered the bar and got a table near the front door equipped with a 'hookah' smoking pipe. THOMAS stated that they also purchased a bottle of "Patron" liquor, which was at the table with them. THOMAS stated that shortly afterwards an unknown black female subject wearing blue jeans and a white top approached the table and told them it was her hookah. THOMAS stated she told the subject that it was THOMAS's table and hookah, and the subject was mistaken. THOMAS stated that the subject then picked up the bottle off the table and swung it back as if to strike 'Yomma'. THOMAS stated that 'Yomma' grabbed one of the subject's hands and THOMAS attempted to push the subject away from them. THOMAS stated that the subject swung the bottle, striking THOMAS in the forehead, and then grabbed her by the hair.

THOMAS was asked if she had any documentation from either hospital. THOMAS stated she did not have any with her at the time. THOMAS had two videos on her phone which she stated were posted on Instagram and Facebook and which showed portions of the incident. The first video THOMAS showed was a group of people including THOMAS and a black female. THOMAS pointed out as the subject that hit her. Numerous people are visible fighting each other and holding THOMAS, the female subject and others apart. Blood is clearly visible on THOMAS' head and face. The video does not show THOMAS being struck.

THOMAS showed another video which showed the outside of the bar. THOMAS pointed out a female subject wearing a white top and blue jeans fighting outside of the bar. THOMAS stated that it was the same subject that struck THOMAS, but THOMAS stated she was not involved in the incident in the video as it occurred after THOMAS had left for the hospital.

THOMAS had a large laceration in the center portion of her forehead which had been closed by 12 stitches and was swollen. THOMAS complained of headache pain throughout the interview.

I (PO LETTEER) did watch the videos and I did observe a black female walking in the bar who

had taken off her white shirt, walking around in a black bra, holding the white shirt to her head, to help control bleeding. THOMAS was also observed on an outside camera exiting the bar, still holding the shirt to her head with blood on it. THOMAS was not observed after this.

We informed LOCKETT of this and he stated that he was in contact with a female, possibly THOMAS and that they were discussing the situation.

PO MACRAE and I then also informed LOCKETT of the two individuals who we observed outside of the bar, on the exterior camera with firearms waiting outside of the bar. LOCKETT did not know this and stated that he had fired his security company Carlos SINGLETON, head of his security and his team. LOCKETT stated he was in the process of looking at 3 reputable, insured security companies to conduct security at the bar. LOCKETT stated that the city had informed him that the bar can only have 25% capacity from now on and that he had a meeting with the licensing committee on 03-09-21.

We informed LOCKETT that we would have to file this report because the incident happened inside of his establishment.

PO MACRAE and I left the bar and shortly after we were informed by the Late Shift Desk Sergeant that there was another person who was hurt as a result of the fight (IR 21-060-0007).

On 03-01-21 at 12:21 a.m., squads were sent St. Joseph's Hospital for a battery cutting. Upon arrival officers spoke to Yasmine A FERGUSON. FERGUSON stated she was at Skybox located at 2213 N Martin Luther King Dr. celebrating. At approximately 11:00pm, she got into a verbal altercation with about 15 other unknown females regarding the use of a hookah that FERGUSON claims to have purchased. One of the unknown females stated she was the one that purchased the hookah and wanted to smoke from it. FERGUSON told the female that she couldn't because she didn't pay for it. FERGUSON then exchanged heated words with the unknown females. Then an unknown female went to hit FERGUSON with a bottle, however, one of FERGUSON's friends blocked the attempt. FERGUSON and her friends then went to leave. FERGUSON was struck once in the face with a bottle, resulting in a contusion to her right eyebrow.

Upon leaving Skybox, FERGUSON and her friends were walking to the car when some of the unknown females pulled up in a car and continued the verbal altercation. The unknown females exited the vehicle and threw a bottle at FERGUSON, striking FERGUSON in the back of the head. The resulting laceration to the back of FERGUSON's head required 4 staples to close.

On 02-03-21 at 11:03 p.m., we went to the location of 2213 N Martin L. King Jr. Dr., Skybox Sports Bar, a licensed tavern in the city of Milwaukee, in order to check and see if the business was open for business.

We found on 01-31-21 that the business did not renew their Class B License which expired on 01-20-21. We were informed by other officers that the bar was not to be open, due to the agent, Toi-Lisa MARK attempting to get a Provisional License on 02-01-21, by contacting Alderwoman COGGS office.

On 02-03-21 we went to the bar and found the bar open for business. We entered the bar and spoke to Royce LOCKETT, the manager of the bar. We inquired about his bar and the status of the license. LOCKETT stated that had spoken with the city and paid a fee. He showed PO MACRAE emails regarding the interaction with the City Licensing Division and was verbally informed as well that he was good to be open. We left the business and informed LOCKETT that we would file this report.

PO MACRAE inquired with MPD Licensing Unit regarding the provisional license. It should be noted that LIRA did not show any application or license issued for a provisional license. It was also believed that if one was issued that due to COVID, the LIRA system may take time updating.

An email was later sent out from Licensing, stating that there was no provisional license issued to Skybox and that the applicant filed a late renewal and that a provisional license would be issued in the order it was received. The email continued that Alderwoman COGGS approved the provisional license, but it could not be entered and issued until the renewal is entered and all the fees are made. Another email was received stating Alderwoman COGGS approved the provisional, but it still has not been issued and that they should not have been operating on 02-03-21.

It should be noted while speaking to LOCKETT, he stated that he was told that he was good to operate after paying fees. I informed him that lately we have been running into the city telling bar owners that they were good to operate after paying fees, even though the license has not been granted by the common council or issued to the owner or agent. By the city telling owners or agents that they are good, they are under the belief that they can operate.

I was informed on 02-04-21 by our CPU Unit, that there was a call with the owners of Skybox in regards to their license status. I was informed that the bar is not to be open due to the status of their license and that later that night (02-04-21) there was to be a party with a DJ. We did drive by the business later on that night and found that the business was closed to the public.

On 12/11/19 at 7:51 p.m., I conducted a license premise check of Skybox Sports Bar, located at 2213 N. Martin Luther King Jr. Dr., which is a licensed premise in the city of Milwaukee.

Upon entering the establishment, I was met by the manager, Royce LOCKETT, who showed me his Class B Tavern License (206868), which is set to expire 01-18-20.

I asked LOCKETT if the bar was going to be open for New Year's. LOCKETT stated the bar would be open until 3:00 a.m. and that he would be closing the doors at 2:00 a.m. He stated he will have 4 security guards inside of the bar, with 2 guards armed, with one of them at the main door. LOCKETT stated he would be hiring 4 extra guards from an external company. He stated other guards would be outside on the street, with one guard in the city lot just to the north of the bar. LOCKETT stated there would be no bands or DJ and that he would not be charging to get in.

LOCKETT stated he would be there, along with 4 other bartenders. On 05-01-20 at 10:54 p.m., we conducted a business check of the SkyBox Sports Bar, located at 2213 N. Martin L. King Jr. Dr., in the hopes to speak to the manager Royce LOCKETT, due to PO MACRAE and I receiving an email that was sent down from Alderwoman COGGS's office, regarding a possible violation of the stay at home order, issued by the Governor. It should be noted that I did send an email to the agent, Toi Lisa MARK, and informed her that we received the email and reminded her in the email that with a food license the bar could be open for curbside pickup or delivery, but that the bar could not be open for people inside of the bar consuming food or alcohol beverages.

Upon arrival, the bar had the front door locked with a television on. We were let inside of the bar by LOCKETT, who was with two other employees and the smell of food was in the air. We informed LOCKETT we were there to discuss the email and possibly where the information from the original email may have come from. LOCKETT stated he knew where the email came from, that a few days prior they were making food and extremely busy. He stated that he was maintaining social distancing and only allowing a certain number of people inside to get food. He stated there was an Uber driver who came to the bar and wanted food for a delivery. LOCKETT stated the Uber driver wanted to come in before everyone else, but was told to go outside to the end of the line and wait, that the bar was following social distancing guidelines.

LOCKETT stated the Uber driver then took a picture of all the people at the bar, posting that Skybox was "Crackin", posting it online. LOCKETT stated he called Alderwoman COGGS's office and was informed that there was no complaint and that he explained the situation to COGG's office. LOCKETT stated he does not want anything bad to happen to the bar, he does not want to put his license in jeopardy and that he will follow the guidelines until the ban is lifted.

We informed LOCKETT that we would be filing this report on behalf of the bar.

This license premise report is written by PO David LETTEER, assigned to Sq. 5468 with PO Russell MACRAE, District 5 Tavern Car.

On 07-05-20 at 12:54 a.m., Sq. 5371 (PO MAUCH and PO LABENSKY), along with Sq. 5465 (PO MARITATO and PO MILONE) were dispatched to the location of 2213 N. Martin L King Jr Dr., Skybox Sports Bar, for a report of shots fired. The CAD had information that there were 3 to 4 subjects with guns, attempting to fight an employee inside of the bar. The CAD was updated that a female heard people yelling and went to the door and saw the gun, but did not get a good look at the subject. The female was advised to keep the doors locked.

As squads arrived, they realized that there were many vehicles, as well as people outside of the bar and that they did not observe anyone fitting a description that was given of the subjects, when the call was taken. As Sq. 5371 was in the area of the call, they observed that N Martin L King Jr Dr., just south of W. North Ave., in front of the bar was blocked by cars with their flashers on and other cars parked on the street, unoccupied. They also observed an estimated 100-125 people outside of the bar, lined up and down Martin L King Jr Dr., as well as W. Garfield Ave. They also observed people setting off fireworks in this area.

As Sq. 5371 was in the area, they stated they were approached by a person claiming to be a Sergeant or former MPD Sergeant, as well as claiming to be the owner of the bar, requesting that a female in front of the bar needed to be removed. Due to the amount of people outside, it was not safe for officers to engage the crowd. They could not locate the person with the gun and left the area.

After reviewing the CAD, one of the callers is typed in as former MPD SGT Royce, who is Royce LOCKETT, a manager of the bar, husband of the listed agent.

At 1:30 a.m. on 07-05-20, a call was created for a subject with a gun complaint at 2213 N. Martin L King Jr Dr., Skybox Sports Bar. The caller, who identified himself as Royce Lockett, former MPD SGT stated that the subjects from the prior shots fired complaint never left and are still outside of the bar, with guns waiting on an employee to leave the bar. The CAD also documents that the caller was upset that he was told by the squads and the shift Lieutenant, that squads would not approach the location due to the amount of people at the bar. Caller stated that now there are only 3 or 4 people and they have guns.

PO MACRAE and I responded to the bar and upon arrival, we observed several hair pieces, as well as earrings lying on the sidewalk in front of the bar and just to the north of the bar. We began to speak to staff and Royce LOCKETT.

I spoke to bar security, who informed me that a black female had entered the bar through the rear alley entrance door and

entered the bar. Security was informed by wait staff that she came from the rear of the bar, where employees should only be and came into the main area of the bar. Security stated once the staff pointed out the female, they asked her to leave. As security was getting her to leave, she became loud, yelling "I ain't going out that door" and "Don't touch me, I am warning you!" The female who was yelling at the security guard, stepped back and let another security guard try to get the female out of the bar. As the second guard was trying to have the female leave, the female attempted to punch the security guard. Ultimately the guard was able to get the female to leave.

Security informed me that she might have been angry because her wig had fallen off in the bar. The female was asked to come back to the bar the next day, in order to resolve any situation with the bar or security. The female, while outside began calling people on her phone, while some other people were getting her to leave. The father of the female arrived and spoke to security, who ultimately removed her from the bar area. Security believed that the female had called others to the bar and believed that there were people who may have guns, who were waiting for the security guards to leave.

Security asked if we could walk one security guard to his car, which we did and the security guard left without incident.

As I was speaking to the security persons, PO MACRAE spoke to the manager, Royce LOCKETT.

PO MACRAE spoke to LOCKETT about calling and identifying himself as a former SGT., with the Milwaukee Police Department. PO MACRAE reminded him that when calling, he should not identify himself as a former SGT. One of the officers that responded is a newer officer and believed that he may be a SGT. with the Milwaukee Police Department, which led the officer to ask other officers if he was a SGT. with the department. LOCKETT is not employed with the Milwaukee Police Department at this time.

PO MACRAE did also speak LOCKETT about the large crowds and vehicles that have been observed since opening to patrons inside of the bar. LOCKETT stated to PO MACRAE that the crowds that were in front of his bar tonight were not his patrons, but patrons that were at the lake front and were in front of the bar.

LOCKETT was informed that a license premise report was going to be completed regarding this incident.

## **PARKING TROUBLE (CAD# 20-285-2055)**

On 10/11/2020 at approximately 09:35pm, PO David LETTEER and I (SQ#5468) were on routine patrol checking on the crowd size of SKYBOX SPORTS BAR. Upon arrival, we observed numerous vehicle parked illegally in posted "No Parking" zones near and in front of the tavern. PO LETTEER and I began to issue parking citations to vehicle regarding. PO LETTEER and I issued approximately **(11)** parking citations. I observed a very large crowd standing outside waiting to get inside the tavern. PO LETTEER and I estimated the crowd waiting at approximately **(50-80)** subjects waiting to enter the tavern in line. The garage/window to the tavern was up/open. I heard the DJ inside over the speaker system say "Bar is closed...bar is close, everyone out". I then observed security inside escorting a loud/angry patron towards the front door. At that time, all of the patrons inside began to walk out of the tavern's front entrance. Patrons began to yell/scream at each other. I notified dispatch at approximately 10:06pm to send more squad cars to our location because I suspect a large fight was about to occur.

## **FIGHT (CAD# 20-285-2109)**

Numerous squads responded to our location. I directed responding squads to block north/south bound traffic to prevent vehicles from running over the patrons who were now spilling into N MLK Drive. Approximately (200) subjects were now on the sidewalk and in the street in front of the Tavern. A large group of which began to fight near the tavern. I notified dispatch of the active fight.

Police began to push the crowd away from the Tavern and off of N MLK Drive. Officers attempted to break the fight up, however they continued. Officers were forced to utilize their OC-(Pepper Spray) to break the fight up and prevent them from harming each other. PO TERRELL and PO MERKEL made (3) arrests of subjects who were fighting. They were later conveyed to District 5 for processing.

## LICENSEE STATEMENT

I made contact with Toi-Lisa MARK (B/F 10/06/71) - SKYBOX Licensee, and her husband Royce L. LOCKETT (B/M 02/26/72). I asked MARK how many patrons she had inside her bar tonight. MARK had a woman who was the counter assigned at the front door come over to us with her "clicker". The woman stated that every time someone entered she added them, and every time someone left she deleted a number off. When I looked at the "clicker" it showed **(173)** on it.

I asked what was the reason for the closure of the bar. LOCKETT stated that security was removing a patron from the bar. While escorting the patron to the door, the patron became upset and had ultimately struck one of the security guards identified as "T.J." At that time, the patron's friends became involved in the fight and it escalated from there. LOCKETT stated that he was struck during the fight as well.

I asked LOCKETT what the bar capacity was; he stated **(300-350)**. I informed LOCKETT and MARK that due to Covid-19 that they as a bar needed to maintain lower numbers than normal for patrons allowed inside. MARK stated that they were in compliance for the City of Milwaukee, and not for the State of WI recent Governor's Orders. MARK stated that City of Milwaukee bars were allowed to maintain higher number of patrons than the rest of the state. MARK stated that she had received a letter from Mayor Barrett / City Hall regarding the specifics. I asked how many staff were currently working. MARK stated **(8)**. MARK stated that there were **(7)** security working as well.

Due to recent continuous issues regarding parking, reckless driving, large crowds, and gun being stolen from patron's parked vehicle MARK and LOCKETT have had several meetings with District 5 Community Prosecution Unit and Captain David FELDMEIERS. SKYBOX is had been attempting to come to a resolution to the problems that have been occurring. As of late, SKYBOX has been utilizing large reflective/orange cones to block no-parking zones to prevent vehicles from parking. The cones have worked very well as long as they are not moved by the patrons.

MARK stated that she has recently discovered that SKYBOX has been paying a specific city tax that also funds Milwaukee Police "CODE-RED" deployment. The "CODE-RED" deployment is utilized for all taverns/clubs in the downtown area (Water Street / Old World Third Street / E Juneau Street). MARK stated that she would be researching to see if she is able to have police officers assigned to her bar as well during "CODE-RED" deployments. I informed MARK that if she qualified for "CODE-RED" that would help for all of the recent problems significantly.

I informed MARK to contact PO LETTEER and I regarding any updates on "CODE-RED" and her bar.


