



- WILL HAVE A BROOM FINISH. JOINT CONTROL CUTS TO BE MADE IN ORDER TO PREVENT
- CRACKING AND MOVEMENT. CONCRETE WORK WILL BE EDGED AND HAVE FIBERMESH
- EXPANSION JOINT WHERE REQUIRE

NOTE: The buyer should not put salt on the concrete work for the first two years; doing this will cause peeling and popping damage to the surface. In addition, the buyer should not park or drive on the concrete for twelve days to ensure proper curing and hardening. The job has a two year warranty, excluding cracking due to the weather, i.e. movement in the ground caused by ice frost and freezing.
