Officers responded and no one answered the door, and the mail had accumulated throughout the week. I gave the officers authorization to force entry to make sure PATTON was not injured. Officers made entry and found PATTON sound and not a danger to himself or others.

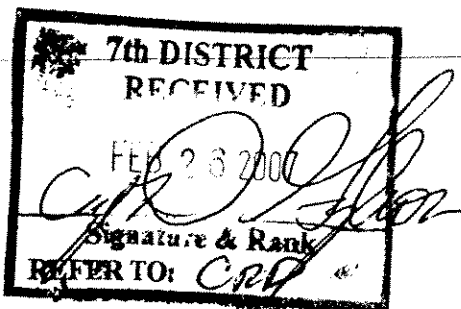
