This office is in receipt of your claim in the amount of \$3,815.00, relating to the removal of debris from your property located at 2723 North Weil Street on March 30, 2004 by a contractor hired by the City of Milwaukee

Our investigation reveals that the Department of Neighborhood Services records indicate that they inspected your property on February 27, 2004 and found that a litter nuisance was present. The nuisance consisted of scrap wood, plastic containers, plywood, rotten fruit, scrap metal, metal pipe, boxes of debris, cushions, carpet, clothing, furniture and all other debris on the property. An order for clean-up was posted on the premises that day. It was mailed to you at 2723 North Weil Street on March 2, 2004. Your property was re-inspected on March 10, 2004 and revealed that half of the debris had been removed. The department spoke with you that day and granted an extension until March 18, 2004. Your property was re-inspected on March 25, 2004 and revealed that half of the debris had been removed. The City hired a contractor who performed a clean-up on March 30, 2004. The department acted appropriately in this matter and as such, the City would not be liable. Accordingly, we are denying your claim.
