This report is written by PO Jason ORTIZ assigned to District Four Late Shift Squad 4322.

On Sunday June 8, 2025, at approximately 2:56 AM I was dispatched to the location of 7928 W. Clinton Ave for a MVA call of service.

Upon arrival I spoke with the victim, identified as Kenneth D SMITH (B/M DOB 6/18/1987) who stated a unknown subject went into the locked parking lot and took their vehicle. SMITH stated he towed the vehicle to his shop which is the listed location and the "owner" of the vehicle demanded the vehicle back. SMITH stated there was another vehicle there that rammed the gate and broke it to gain access to the back parking lot where the vehicle was being held. SMITH stated he does not know who was in the vehicle that hit the gate. Smith stated the unknown suspect who had a key to the vehicle in the lot entered the vehicle and drove through the gate causing damage to the gate. SMITH stated none of the parties had permission to be on the property at that time due to it being after business hours. SMITH could not confirm who the individuals were. SMITH stated he will contact his insurance company to get his gate fixed.

I was not able to obtain any video footage.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.


