Dear Ms. Hess:


This office is in receipt of your claim in the amount of \$930.00, relating to items missing from your property located at 124 East North Avenue on December 16, 2003.

Our investigation reveals that the Department of Neighborhood Services records indicate that they inspected your property on December 4, 2003 and found that a litter nuisance was present. The nuisance consisted of pots, drywall, metal poles, scrap wood, golf cart, loose debris and all other debris on the property. An order for clean-up was posted on the premises that day. It was mailed to you at 124 East North Avenue on December 5, 2003. Your property was re-inspected on December 11, 2003 and revealed that some of the debris had been removed. The City hired a contractor who performed a clean-up on December 16, 2003. The department acted appropriately in this matter and as such, the City would not be liable. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
