

PARCEL "A"

That part of Lands in the Southwest 1/4 of Section 9, Township 7 North, Range 22 East, described as follows: Commencing at a point of intersection of the south line of East Keefe Avenue and the northeasterly line of Cream City Heights, a recorded subdivision, in said 1/4 Section, said point lying 33.00 feet south of, as measured normal to, the north line of said 1/4 Section; thence Southeasterly, along said northeasterly line, to a point in the present west line of North Holton Street; thence Northerly, along said present west line, to a point in the southwesterly line of Webster Avenue Heights, a recorded subdivision, in said 1/4 Section; thence Northwesterly, along said southwesterly line, to a point in the south line of East Keefe Avenue, said point lying 33.00 feet south of, as measured normal to, the north line of said 1/4 Section; thence Westerly, along said south line, to the point of commencement. Excepting there from the following described lands: Commencing at the point of intersection of the east line of North Buffum Street and the southwesterly line of said Webster Avenue Heights; thence Southeasterly, along said southwesterly line, 200 feet more or less to a point; thence Southwesterly, to a point 18.00 feet southwesterly of, as measured normal to, said southwesterly line; thence Northwesterly, parallel to said southwesterly line, 175 feet more or less to a point lying in the southerly extension of the east line of North Buffum Street; thence Northerly, along said southerly extension, to the point of commencement.

PARCEL "B"

That part of Lands in the Southwest 1/4 of Section 9, Township 7 North, Range 22 East, described as follows: Commencing at the point of intersection of the present south line of East Townsend Street and the southwesterly line of Wm. P. McLaren's Subdivision No. 1, a recorded subdivision, in said 1/4 Section; thence Southeasterly, along said southwesterly line and the southwesterly lines of Auer's Subdivision No. 6 and C.K. Reichert's Subdivision No. 4, recorded subdivisions, in said 1/4 Section, to a point in the present west line of North Booth Street; thence Southerly, along said present west line, to a point in the northeasterly line of Bannen's Subdivision No. 1, a recorded subdivision, in said 1/4 Section; thence Northwesterly, along said northeasterly line and the northeasterly lines of H.J. Mathews and Brothers Subdivision No. 2 and Cream City Heights, recorded subdivisions, in said 1/4 Section to a point in the present east line of North Holton Street; thence Northerly, along said present east line, to its point of intersection with the present south line of East Townsend Street; thence Easterly, along said present south line, to the point of commencement.

PARCEL "C"

That part of Lands and parts of Lots 10 and 11 of Plat of the E. 1/2 of S.W. 1/4 of Sec. 9-7-22, a recorded subdivision, in the Southwest 1/4 of Section 9, Township 7 North, Range 22 East, described as follows: Commencing at the point of intersection of the present south line of East Concordia Avenue and the southwesterly line of C.K. Reichert's Subdivision No. 4, a recorded subdivision, in said 1/4 Section; thence Southeasterly, along said southwesterly line and the southwesterly line of Auer's Subdivision No. 4, a recorded subdivision, in said 1/4 Section, to a

point in the east line of North Pierce Street; thence Southerly, along the southerly extension of said east line, to a point lying 75.00 feet southwesterly of, as measured normal to, the southwesterly line of Auer and Richter's Subdivision, a recorded subdivision, in said 1/4 Section; thence Southeasterly, parallel to said southwesterly line, to a point in the present north line of East Auer Avenue; thence Westerly, along said present north line, to a point in the northeasterly line of Moan and Stramm's Subdivision No. 1, a recorded subdivision, in said 1/4 Section; thence Northwesterly, along said northeasterly line and the northeasterly line of W.P. McLaren's Subdivision No. 2, a recorded subdivision, in said 1/4 Section, to a point in the present south line of East Concordia Avenue; thence Easterly, along said present south line, to the point of commencement.

PARCEL "D"

That part of Lot 14 of Plat of the E. 1/2 of S.W. 1/4 of Sec. 9-7-22, a recorded subdivision, in the Southwest 1/4 Section 9, Township 7 North, Range 22 East, described as follows: Commencing at the point of intersection of the present south line of East Auer Avenue and the present west line of North Fratney Street; thence Southerly, along said present west line, to a point in the northeasterly line of Moan and Stramm's Subdivision No. 1, a recorded subdivision, in said 1/4 Section; thence Northwesterly, along said northeasterly line, to a point in the present south line of East Auer Avenue; thence Easterly, along said present south line, to the point of commencement.

PARCEL "E"

That part of Lots 14 and 15 in Plat of the E. 1/2 of S.W. 1/4 of Sec. 9-7-22, a recorded subdivision, in the Southwest 1/4 of Section 9, Township 7 North, Range 22 East, described as follows: Commencing at the point of intersection of the present east line of North Fratney Street and the southwesterly line of Auer and Richter's Subdivision, a recorded subdivision, in said 1/4 Section, thence Southeasterly, along said southwesterly line and the southwesterly line of Lot 1 in Block 3 of Moses Kneeland's Partition, a recorded subdivision, in said 1/4 Section, to a point in the present west line of North Bremen Street; thence Southerly, along said present west line, to a point in the northeasterly line of Lot 3 in said Block 3; thence Northwesterly, along the northeasterly lines of said Lot 3 and Lots 2, 13, 14 and 15 in said Block 3 and the northeasterly line of Moan and Stramm's Subdivision No. 1, a recorded subdivision, in said 1/4 Section, to a point in the present east line of North Fratney Street; thence Northerly, along said present east line, to the point of commencement.

PARCEL "F"

That part of Lot 16 in Plat of the E. 1/2 of S.W. 1/4 of Sec. 9-7-22, a recorded subdivision, in the Southwest 1/4 of Section 9, Township 7 North, Range 22 East, described as follows: Commencing at the point of intersection of the present north line of East Burleigh Street and the present east line of North Bremen Street; thence Northerly, along said present east line, to a point

in the southwesterly line of Lot 13 in Block 2 of Moses Kneeland's Partition, a recorded subdivision, in said 1/4 Section; thence Southeasterly, along said southwesterly line, to a point in the present north line of East Burleigh Street; thence Westerly, along said present north line, to the point of commencement.
