Dear Mr. Dotson:


This office is in receipt of your claim in the amount of \$927.00, relating to damage sustained to your property on February 13, 2004 when backwater from a clogged sewer drain flowed into your basement at 3706 West Sheridan Avenue.

Our investigation reveals the sewer in question was on a three year cleaning schedule. The last time the sewer was cleaned was on June 24, 2003. Because the sewer was on a regular cleaning schedule and the City of Milwaukee did not have any notice of any problems with the sewer, the City cannot be held liable.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
