

I am seeking to recover \$500 deductible, \$92 for one day salary, \$20 medical fee, and

\$189.30 cost for auto rental. All applicable documents attached. On December 18, 2002 around 8:20 my left front tire hit a hole in the road (at 2nd and Cherry St) that was not properly topped off after construction or repairs. My left wheel hit the sink hole with a loud bump and I immediately heard a scrubbing noise and a swishing sound. I immediately pulled the car over examine the wheel and saw that tire had lost most of its air. I walked back a few feet to see what had happen and discovered that I had hit the hole which was not properly topped off. I phoned for a non emergency squad car that arrived about one hour and 15 minutes later. The officer examined my car and looked at the hole and explained that I possible had undercarriage damage to the front left wheel of my car. He suggested I try to get it looked at right away to avoid further damage. He also assured me that he would contact the city to have the hole properly filled in. I drove a few blocks hoping to get to service station but to no avail. I then phoned for road service. The service technician then changed to the small tire so that I may get the car to Braeger Chrysler for repairs. They allowed me a rental car. I returned home at around 3pm feeling gas pains in my stomach some soreness around my lower back and shoulder. That afternoon I did go to see an urgent care physician and he stated that I possible had a pretty nervous morning and what I was feeling was normal after being a bit frighten and shook up by the bump. He recommended Tylenol. I reported the incident to my insurance company, but I need to pay a \$500 deductible. However, they will cover a rental until repair is finished. Braeger finished the car on Tuesday afternoon (12/31/02),

but I didn't have the deductible to pay them to get the car out. So I borrowed the \$500 to avoid additional rental expenses.

I have attached a copy of the police report, bills for the deductible, one (1) day salary, rental cost and for doctor visit.

I would appreciate any immediate consideration in this matter.
