Part 3. Section 78-25 (2) (a) of the code is hereby amended to read:

Section 78-25. Penalties.

(2) Stipulation Procedure for Dog Licensing, Stray Animal, Noisy Animal, and Animal Littering Violations.

(a) FORFEITURE.

Where citations are issued for violation of Sections 78-8, 78-9 and 78-13 (2) the alleged violator shall be subject to the following forfeiture: if paid within five (5) days commencing on the day following the day the citation is issued, the forfeiture shall be five dollars (\$5); if paid after five (5) days, the forfeiture shall be ten dollars (\$10). Forfeitures paid after twenty-eight (28) days shall be determined by the court and shall be subject to a maximum forfeiture of two hundred dollars (\$200) for each offense together with the costs and disbursement of prosecution. If such persons shall continue in violation they shall be liable for further prosecution, conviction and punishment with each and every occurrence constituting a separate offense.

Part 4. Section 78-25 (3) of the code is hereby amended to read:

Section 78-25. Penalties.

(3) OTHER VIOLATIONS.

Any person violating any provision of Section 78-3 thru 78-7 inclusive; 78-11, 78-12, 78-13 (1) and 78-14; 78-16 thru 78-20 inclusive; and 78-22 thru 78-24 inclusive, or who shall fail, omit, neglect or refuse to obey any order issued pursuant to these sections shall, upon conviction, be subject to a forfeiture. Such forfeiture shall be not less than ten dollars (\$10) nor more than two hundred dollars (\$200) for each offense, together with the costs and disbursements of prosecution. Upon default or refusal to pay such forfeiture, such person shall be imprisoned in the county jail or house of correction for not less than ten (10) days nor more than ninety (90) days. If such person shall continue in violation of such order, then such person shall be liable for further prosecution, conviction, and punishment upon such same order, without the necessity of the commissioner of health issuing a new order.

Part 5. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 6. This ordinance shall take effect and be in force from and after its passage and publication.

AN ORDINANCE

(c) Location of Commuter Parking Impacted Areas. St. Luke's Hospital residential area, located between S. 28th Street and S. 34th Street from W. Lakefield Drive, S. 31st Street and W.
