#### Work Performed at 524 W. Historic Mitchell Street, Milwaukee

- Tuck pointing of east elevation of church between the two towers performed by Holton Brothers, Inc. Contractors.
- Roof repair of saddles and flashing at east elevation of church and replacement of Yankee Gutters at Rectory performed by Millen Roofing Company.
- Exterior Storm Glass Window replacement of south and north elevations of church performed by Conrad Schmitt Studios Inc.

#### Work Performed at 1669 S. 5<sup>th</sup> Street. Milwaukee

- Tuck pointing of south, west and north elevations of old school building performed by Holton Brothers, Inc. Contractors.
- Roof replacement of south, west and north shingle roof elevations and modified roof top of old school building performed by F.J.A. Christiansen Roofing Company, Inc.
- Yankee Gutter replacement of south, west and north elevations, collection box and one down pipe of old school building performed by Millen Roofing Company.
- Painting of cornices of south, west and north roof elevations of old school building performed by Kellmann Restoration.

All the work described and performed is necessary due to the age of the buildings and failure of these systems due to weather exposure resulting in weather damage to the structures.

It is our goal to complete these necessary repairs and building maintenance work to prevent future damage and preserve these historic buildings.

No structural changes or modifications are being made to either building.
