Hello -

I'm writing to express my opposition regarding the proposed development of a gas station at 6418 W. Mill Road (#BZZA-25-00271).

I have lived in the area for 43+ years and don't see a need for another gas station in our community and certainly not at this location. There already are two gas stations in the 76th and Mill Road area and another on 43rd and Mill Road. Putting another one in the middle of the existing three gas stations is an over saturation of a business that isn't needed.

I have worked with Block Watches and residents of the area for over 22 years and I've attended hundreds of meetings with those residents. Never at these meetings, has anyone ever said they wished we could have more gas stations. What I have heard are complaints. Complaints of existing stations and the loose garbage that comes from this type business and flows into neighborhoods, the drain of an already limited Police Department that responds constantly to calls at these businesses, unkept stations that have had to be written up with DNS, and a general complaint that the business actually effects their quality of life with negative activity.

I'm asking that BOZA and Alderwoman Taylor show their support to our community and deny this application.
