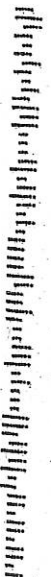

I'M WRITING THIS DOCUMENT TO ADDRESS A SITUATION THAT RESULTED IN DAMAGE BEING CAUSED TO MY VEHICLE. THE INCIDENT OCCURRED ON 8/12/19 AT THE LOCATION OF 30TH AND NORTH AVE.
