The Milwaukee Police Department's investigation regarding this application revealed the following:

The below items pertain to 3717 N. 76<sup>th</sup> Street.

1. On 03/04/25, at 6: 00 p.m., officers conducted a CPTED inspection of the business. The agent was on scene and cooperative.
2. On 11/09/25, at 11:00p.m., officers were dispatched to a Battery complaint. A security guard reported a known subject that slapped a female. The subject belligerent and intoxicated fell on the floor where they laid for short period of time. Both the female and subject left prior to officers' arrival. Officers questioned why is the subject allowed in the business when they continue to cause problems. No security camera footage was available of the incident.
3. On 11/20/25, at 5:59 p.m., an officer responded to a 911 call for service. The dispatcher stated there was an open line and someone could be heard yelling. Upon arrival no one at the business claimed to have called. No additional services needed.
4. On 11/29/25, at 11:20 p.m., an officer was dispatched to a Battery complaint. The caller stated they were kicked in the stomach by one of the business owners. It was confirmed the caller was not kicked, but did take a beer bottle and threw it the owner. The bottle missed the owner but caused minor damage. The caller was escorted out of the business by a security guard and advised they are not allowed back in the property.

Upon arrival I spoke to security, Diangelo M. Stewart (b/m, 08/14/85) who stated there was an intoxicated patron who struck a female. Stewart stated the female left and the patron who was identified by his credit card he left as William Edwards fell to the ground at some point but left the location as well. Stewart stated Edwards has come into the location several times intoxicated and belligerent. I asked Stewart why the establishment allows him to come in but he did not have an intelligent answer. Stewart did however have a picture of Edwards laid out on his back in the entrance way of the establishment. I asked Stewart if anyone hurt Edwards to which he stated no.

I asked Stewart if the business had video surveillance that would have captured this incident to which he stated no.

I spoke to the manager on duty, Lagrant, who stated he did not know the patron and did not see the incident. Lagrant seemed to be preoccupied with smoking his cigarette then in helping me in my investigation.

This report is written by P.O. Taylor MOTIFF assigned to District 7 Late Power shift Squad 7468.

On Saturday, November 29, 2025 at approximately 11:20 PM I was dispatched to 3717 N 76th St (Schneider's Food & Drink) for a Battery complaint.

Upon arrival my partner, P.O. Alexander HAHN, spoke to the caller, Candaice B HOWARD (B/F 11-11-1981), who stated that her on again off again boyfriend, Montal L HINTON (B/M 02-20-1971), had kicked her in the stomach multiple times and pushed her down the stairs inside the bar by the front door. HOWARD stated she did not need medical treatment.

I spoke to HINTON, one of the owners, inside the location who stated that he did not strike HOWARD at all. HINTON stated that HOWARD had gotten mad about something, reached over the bar and grabbed a beer bottle, walked toward the front door, and threw the beer bottle back at him. The bottle missed him, went behind the bar, and broke a bottle of Bacardi rum. HINTON stated he told HOWARD she needed to leave and security, Diangelo M STEWART (B/M 08-14-1985), walked her out of the location. HINTON did not want to press charges for anything, just wanted HOWARD to be told she wasn't allowed back at the location.

I spoke to STEWART who stated that he was seated to the right of HINTON and HOWARD at the bar because they were closing. STEWART stated that they began arguing and had both stood up behind him. STEWART stated HOWARD then grabbed a beer bottle and walked towards the door. STEWART stated that HOWARD stopped and threw the beer bottle back towards the bar and it broke a liquor bottle. STEWART stated that he then escorted HOWARD out of the bar and as she began walking into the parking lot she shouted that she was going to call the police and tell them that HINTON had assaulted her.

The business agent, Dion REED (B/M 07-28-1970), was on scene at the time of the incident and when we

responded. I asked if his cameras inside the location were working and he stated that they only are running live feed and are not recording. REED requested that HOWARD be advised that she is no longer welcome at the location. I gave REED and HINTON restraining order information and advised HOWARD she wasn't allowed back at the location.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
