## 5. DESCRIPTION OF PROJECT:

Our customer has asked us to design, fabricate an outdoor sign for their new restaurant opening within the history building located at 811 N. Jefferson Street. The desired location and placement of the sign is above the main entry door, mounted flush to the architectural prize detail. Beyond conveying the name "SAFINA", the design intent is to blend as seamlessly as possible with the architecture and ultimately maintain it's historic significance. By keeping the aluminum sign cabinet/pan as low-profile as possible (only 2") and by matching the color (white), the intent is for it to visually "drop-out" as much as possible, with only the "SAFINA" characters being noticeable. They are to be CNC-routed from 3/4" thick clear acrylic with the faces clad with 3M Duranodic Bronze opaque vinyl, and they are to "push-thru" the routed aluminum sign face also painted white. They are backlit by means of internal LED illumination (warm white; 3000K) and will effectively appear to be halo-illuminated at night -by light emitting through the sides of the 3/4" thick clear acrylic characters. The overall dimensions of the sign are 72.00" long by 8.50" high by 2" deep. The sign will be both elegant and timeless.
