Dear Alderman Bauman:

We previously covered the two-hour parking restriction on West State Street from North 33<sup>rd</sup> Street to North 35<sup>th</sup> Street and the no parking restriction on the south side of West State Street from North 35<sup>th</sup> Street to a point 65 feet east on a trial basis. This trial has been in effect for a substantial time period and we have not received any complaints. Therefore, we recommend a permanent removal of the parking restrictions.

We will prepare the necessary legislation that will be heard at the next Public Safety Committee meeting, so that you may support it to final passage.

Dear Alderman Donovan:

This is in response to your request on behalf of local residents to install the above-captioned winter parking restrictions.

Department of Public Works staff has investigated this request and found that the above-captioned street has not met the recommended street width criteria to install the requested "No Parking When Snowfalls 4" or More" restriction, since this street has a street width of thirty feet, and the minimum recommended street width for a roadway to have this restriction posted is thirty-six feet.

However, in compliance with your request, this legislation will be prepared for consideration at the next Public Safety Committee meeting for this winter parking restriction.
