



Objection to June 30, 2017 Report of the Licenses Committee and Findings of Fact, Conclusions of Law, and Recommendation

Dear Mr. Owczarski:

This office represents the above licensee with respect to his application for renewal of his Class B Tavern, Food Dealer and Public Entertainment Premises License. We have received your June 30, 2017 letter forwarding the Report of the Licenses Committee and Findings of Fact, Conclusions of Law and Recommendation, recommending nonrenewal of the subject licenses. Pursuant to § 90-12-5-c-2, *Milwaukee Code of Ordinances* ("MCO"), the licensee respectfully objects to the June 30, 2017 Report of the Licenses Committee recommending non-renewal of Mr. Sagorac's licenses.

The licensee requests that these written objections be considered by the Common Council at its July 11, 2017 meeting. The undersigned will be present at the meeting to present these objections at oral argument and answer questions.

Coach Sagorac's Big Time Pub of Greatness is a small neighborhood pub run by Jerud "Coach" Sagorac, a school teacher for a charter school in Milwaukee. The pub opened less than a year ago. Mr. Sagorac lives above the pub, is its licensed agent, and is present every night the pub is open. Although he has some limited previous experience as a bartender and security for bars, this is Mr. Sagorac's first time as a tavern owner.

Mr. Sagorac admits that he initially struggled to implement consistent policies and procedures at his pub and with his employees. Combined with the changing demographics and increasing

difficulties in the neighborhood, these early failures resulted in the incidences documented in the police report presented to the committee. Then in early May, the MPD issued a nuisance letter and a Notice of Mandatory Retail Establishment Security Measures to the pub.

Mr. Sagorac prepared a thorough response, including signage, employee procedures, increased security presence, increased cameras, increased lighting, a standing loitering complaint, earlier closing hours, and increased communication with MPD. This Plan of Action was approved, and Captain Wurth praised the plan during her testimony at Committee.

Although he was not required to implement the Plan of Action until the second week of July, Mr. Sagorac immediately began taking steps to ensure his pub was operating with the best practices and procedures it could. Over the course of the last two months Mr. Sagorac is pleased to report that there have been no issues at the pub.

In recommending denial of the Licenses, the Committee failed to follow its customary and required principles of progressive discipline. Customarily, the Committee applies progressive discipline principles to applicants when considering imposing sanctions. In fact, Wisconsin courts have noted that such principles are appropriate in order to satisfy the equal protection requirements of the U.S. Constitution, 14th Amendment. *See Village of Menomonee Falls v. Michelson*, 104 Wis. 2d 137, 145-46, 311 N.W.2d 658 (Ct. App. 1981).

Rather than finding an appropriate sanction in accordance with a reasonable progressive discipline step, the Committee essentially gave up and just non-renewed the Licenses despite our office's suggestion that a 30-day suspension to be appropriate. The Committee could have — and should have — recommended suspension of the Class B Tavern, Food Dealer and Public Entertainment Premises License thereby giving the licensee a chance to continue to improve and impressing upon it the importance of maintaining a clean establishment. This is particularly true here where, as noted above, the licensee has developed a well thought out Plan of Action that has been approved and endorsed by MPD. Notably, since it began implementing the Plan of Action, the licensed premise has had no reported issues.

The Committee instead arbitrarily voted to deny renewal effectively giving the bar a death sentence even though a lesser sanction in the form of a suspension was more reasonable under the circumstances and applicable law. Non-renewal was an unreasonable penalty in light of the City's progressive discipline principles that should have applied in this situation.

CONCLUSION

Mr. Sagorac recognizes the seriousness of the situation and has already taken responsibility to correct it (by implementing the Plan of Action) and by authorizing us to suggest a 60 day

suspension is an appropriate sanction. This will have the added benefit of allowing the licensee time during which you can to continue to implement his operational improvements.

For all of the foregoing reasons, the licensee respectfully requests that the Common Council renew its Class B Tavern, Food Dealer and Public Entertainment Premises License with a 60-day suspension.
