THIS INDENTURE, Made this _____ day of ______, 2004, between the Housing Authority of the City of Milwaukee ("HOUSING AUTHORITY") (Grantor), a public corporation, duly organized and existing under Chapter 66.1201 of the Wisconsin Statutes, and the City of Milwaukee ("CITY") (Grantee), a municipal corporation, duly organized and existing under and by virtue of the laws of the State of Wisconsin, located at Milwaukee, Wisconsin.

WITNESSETH, That the HOUSING AUTHORITY, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations to it paid by CITY, the receipt whereof is hereby confessed and acknowledged, has given, granted, bargained, sold, remised, released, and quitclaimed, and by these presents does give, grant, bargain, sell, remise, release, and quit-claim unto the CITY, and to its successors and assigns forever, the following described facilities, situated in the County of Milwaukee, State of Wisconsin, to-wit:

Sanitary sewer, manholes and appurtenances thereto located in the Southwest one-quarter (SW ½) of the Southeast one-quarter (SE ½) of Section 19, Township 7 North, Range 22 East in the City of Milwaukee, County of Milwaukee, State of Wisconsin, more particularly described as follows, to-wit:

A 10-inch diameter circular sanitary sewer beginning at the center of a sanitary sewer manhole located one hundred seven and fifty hundredths (107.50) feet south of the south line of West McKinley Avenue, and eighteen and eighty hundredths (18.80) feet east of the west line of North 18th Street.

Thence southerly, three hundred sixty-three and fifty hundredths (363.50) feet to the center of a sanitary sewer manhole, which lies twenty-nine feet south of the north line of West Juneau Avenue at a point eighteen and eighty hundredths (18.80) feet east of the southerly extension of the west line of North 18th Street, said manhole not included in this conveyance and also being the end of this centerline description.

All manholes and appurtenances, connected to the above-described sanitary sewer, which have not been expressly excluded in the aforementioned description, are part of this conveyance.

It is understood and agreed that the grantee herein shall be responsible for the future maintenance or abandonment of the facilities herein conveyed.
