
Dear Mr. Corris:


This office is receipt of your claim in the amount of \$250,000.00, relating to property damage, personal injuries, past and future pain, suffering and disability sustained to your client as a result of an automobile accident. Ms. Place was involved in said automobile accident on February 10, 2000 at the intersection of North 8th Street and West Center Street.

The Wisconsin Motor Vehicle Accident Report completed as a result of this accident noted the police car with its red and blue lights activated had stopped for the red light and then proceeded into the intersection at which time it struck your client's vehicle. Your client failed to maintain lookout and failed to yield the right-of-way to the police car. Since your client contributed to the cause of this automobile accident, the City cannot accept liability for this loss. Accordingly, we are denying your client's claim.

If you wish to appeal this decision, you may do so by sending a letter with in 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
