The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/18/19 at 10:24pm, Milwaukee Police were dispatched to 5601 N. Lovers Lane for a trouble with subject complaint. Upon arrival, officers interviewed the caller/employee who stated that he had a subject, not a guest of the hotel, causing a disturbance and refusing to leave. Officers checked the hotel but could not find the subject.
2. On 01/22/19 at 8:48am, Milwaukee Police were dispatched to 5601N. Lovers Lane for a trouble with subject complaint. Officers interviewed the caller/employee who stated that he has received numerous complaints from guests that the people in room 413 are doing drugs and wanted them removed. Officers went to the room and upon entrance, found no sign of foul play and nobody was inside. The employee was advised to call back if they return.
3. On 03/10/19 at 3:00pm, Milwaukee Police were dispatched to 5601 N. Lovers Lane for a sick/injured person. Upon arrival, officers found the Milwaukee Fire Department treating a subject, who was in his vehicle, in the parking lot of the location, who had overdosed on heroin. The subject was taken to the hospital where he admitted to smoking heroin. An officer made contact with the applicant who was uncooperative on the phone when officers requested his information. The applicant stated to officers "it was not his problem, but ours".

4. On 04/14/19 at 2:53pm, Milwaukee Police were dispatched to 5601 N. Lovers Lane for a trouble with subject complaint. Upon arrival, officers interviewed the caller/employee who stated that one of the guest threatened an employee and wanted him removed from the premise. The guest was escorted off the premise without incident.
5. On 05/11/19 at 12:48pm, Milwaukee Police were dispatched to 5601 N. Lovers Lane for a theft complaint. Upon arrival, Officers interviewed the caller/employee who stated that he caught, on video surveillance, another employee stealing from a guest. Officers observed the incident on camera and contacted the victim of the theft. The caller was informed a report would be filed.
6. On 06/29/20 at 8:48am, Milwaukee Police conducted a license premise check at 5601 N. Lovers Lane Road because of an aldermanic complaint stating that the hotel was operating without a license. Upon arrival officers interviewed the manager of the hotel who stated that she was not aware that the city license was expired and that they have a housing contract with Milwaukee County. She further stated that the hotel is managed by "Kinseth Hospitality Company, the current applicant has little to do with the hotel, and no one had been able to contact the applicant on file with the city. The manager was advised to have Kinseth Hospitality Company contact the city regarding this matter. Officers tried to contact the applicant but were unsuccessful.

On Monday, June 29, 2020, Sgt. Chad RADEN and I conducted a license premise check at Hampton Inn, located at 5601 N. Lovers Lane Rd. This was based on an aldermanic complaint regarding the hotel operating without a license. According to LIRA (License Information Reporting and Administration) the Hotel/Motel License for the establishment expired 07/11/19. An application for renewal was submitted to the License Division on 05/12/20 and is currently pending committee review.

On arrival officers were able to interview, Janice ANDREWCAVAGE, who is a manager at the Hotel. ANDREWCAVAGE advised officers there is currently a housing contract between the Hotel and Milwaukee County. The business is open to the public and she was not aware of the licenses being expired. She was advised the hotel license is expired and the food license is currently valid. ANDREWCAVAGE stated the Hotel is currently being managed by "Kinseth Hospitality Company" and has been since November of 2019. She further stated that Kinseth was preparing to do training of the current employees. She was advised that the current license does not list to Kinseth as operating the business. The current agent is Alpesh PATEL. She stated Patel has little to do with the hotel and no one has been able to get in touch with him. She was advised to contact Kinseth and Patel and have them contact city hall to correct this matter.

I attempted to contact PATEL via 2 telephone numbers listed on his application, with negative results.

I observed the incident the cc-TV, channel 11 which was time stamped for 12:48p.m. at the time of the crime. The video showed the suspect taking the victims duffel bag with his clothes out of his room and putting it in a black plastic trash bag and taking it to the rear of the location. The victim of the theft was identified by his drivers license as Marcus T. WILKS(B/M, 04/21/69). WILKS stated that he did not want to prosecute because the property he needed wasn't stolen by the suspect.

MOOREHEAD identified the suspect of the theft as his employee, Tonda EATON. MOOREHEAD did not have a birthday for her. MOOREHEAD was informed that this report would be filed and he was given a community contact card and PV-17 to reference the case number for this report.


