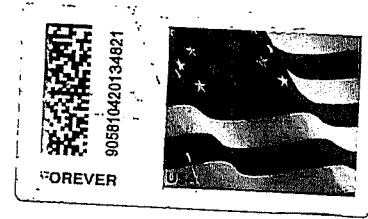

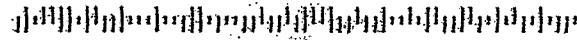

We have received your claim for the amount of \$658.78 in relation to a tow charge you incurred after your vehicle was stolen on October 15, 2022.


