2. On April 8, 2024 Claimant's attorneys received the City's March 20, 2024 letter via USPS. Per conversations with the City's Investigator Adjuster this letter was mailed out on April 3, 2024. When Claimant's counsel reviewed Exhibit 1 on April 10, 2024 it was discovered that the envelope containing Exhibit 1 and the postmark for its mailing had been disposed of and was no longer available.

3. The basis of Claimant's Appeal is as follows:

a. The Wisconsin Motor Vehicle Crash Report #J9L1JN004Z depiction of the travel lanes occupied by the by Claimant, Gabrel Bledsoe, and City Employee, Caryn Jines, is incorrect.

b. Claimant has recordings taken at the scene prior to the arrival of law enforcement which demonstrate Caryn Jines caused the subject matter collision.


