1           CHAIRMAN BOHL: Alderman Kovac.

2           ALDERMAN KOVAC: Thank you, Mr. Chair. I  
3       would like to move reconsideration of the file from  
4       Monday, 2116 North Farwell, where committee  
5       recommended sending to council without  
6       recommendation on a 3 to 1 vote. I'd like to move  
7       reconsideration of that.

8           CHAIRMAN BOHL: And the name of the  
9       applicant for that?

10          ALDERMAN KOVAC: A-List Supper Club, Mark  
11       Brown.

12          ALDERMAN DUDZIK: Mr. Chair.

13          CHAIRMAN BOHL: One moment, I'll let you  
14       on the motion. Motion by Alderman Kovac is to  
15       recommend reconsideration of the Class B Tavern and  
16       Tavern Dance application for 2116 North Farwell,  
17       A-List Supper Club, applicant agent Mark Brown. On  
18       -- are there, is there any discussion on the motion  
19       for reconsideration? On the motion, Alderman.

20 ALDERMAN DUDZIK: I believe I will

21 abstain from the motion for reconsideration as I

22 did not see the entire --

23 CHAIRMAN BOHL: Proceeding.

24 ALDERMAN DUDZIK: -- proceeding and the

25 file. I did view as much as I could but not the

1 whole thing. And I think the city attorney would  
2 back me up by saying I should probably keep my nose  
3 out of it.

4 MR. SCHRIMPF: Well, not in quite those  
5 words, Mr. Chairman, but, yes.

6 ALDERMAN DUDZIK: All right.

7 CHAIRMAN BOHL: Thank you. Alderman  
8 Dudzik will abstain from any items relating to this  
9 application. Other discussion on the motion? Are  
10 there any objections to the motion on  
11 reconsideration? Hearing none, so ordered. The  
12 matter is now again before us.

13 ALDERMAN KOVAC: Mr. Chair.

14 CHAIRMAN BOHL: Alderman Kovac.

15 ALDERMAN KOVAC: I'd like to make a  
16 motion based on the testimony we heard on Monday,  
17 the neighborhood testimony, to grant the Class B  
18 Tavern License but deny the Tavern Dance.

19 CHAIRMAN BOHL: Thank you. The matter we

20 had on Monday had been referred to council without  
21 a recommendation. There had been some discussions,  
22 and I think there were some questions about if --  
23 legality of whether the council could legally do  
24 it. It is something that I do not believe we had  
25 any precedents over. There were certainly concerns

1       that had been expressed, about the precedents on  
2       whether or not the council would then be required  
3       to take testimony or leave itself open for  
4       testimony at the council meeting, something that we  
5       all want to avoid. So to dispose of this here at  
6       committee level would be more appropriate. The  
7       motion by Alderman Kovac is to recommend approval  
8       of Class B Tavern and denial of the Tavern and  
9       Dance supplements based on neighborhood testimony.  
10      Is there any discussion on the motion?

11           ALDERMAN HAMILTON: Mr. Chair.

12           CHAIRMAN BOHL: On the motion, Alderman  
13      Hamilton.

14           ALDERMAN HAMILTON: I would like to  
15      abstain on the motion because I didn't get any of  
16      the testimony.

17           CHAIRMAN BOHL: Alderman Hamilton was  
18      excused from Monday's meeting. So Aldermen  
19      Hamilton, Dudzik will be listed as excused from

20 this vote, as abstaining. Any additional  
21 discussion on the motion? Are there any objections  
22 to that motion? Hearing and seeing none, so  
23 ordered. Thank you.
