Dear Ms. Quiroz:

We have received your claim in the amount of \$197.47, relating to damage sustained to your vehicle on/about July 26, 2004 when you allege a piece of curb located at/near 2826-28 North Holton was used to break your vehicle's windshield.

Our investigation reveals that the Infrastructure Services Division (ISD) reviewed their records and the records of the DPW "Call Center" for the period of July 26, 2003 to July 31, 2004. The "Call Center" search revealed the department did not receive any complaints for this time period for the roadway in the 2800 block of North Holton Street. The search did note a street maintenance crew removed damaged pavement, sidewalk and curb on or about July 12, 2004. The crew poured concrete for the curb and pavement on July 14, 2004. The sidewalk concrete was poured on July 20, 2004 and all barricades for the work site were removed by July 23, 2004. The crew members indicated all of the debris from this project was removed from the construction site prior to the barricades being removed. The ISD followed normal procedures in this matter. When the ISD is notified of a hazard in the roadway a crew is sent to investigate and/or remove the hazard. Prior to your loss the City had no notice of this defect, and because of this lack of notice, it cannot accept liability, as such; we are denying your claim.
