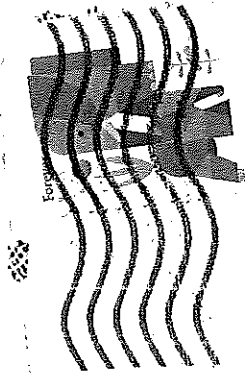

Dear Mr. Ransom:

We have received your claim for the amount of \$20,000.00 in relation to the vehicle damage you sustained on June 21, 2023 in the area of North 37<sup>th</sup> Street and West Highland Boulevard.

Our investigation determined that the Milwaukee Police Department followed standard operating procedures as it relates to vehicle pursuits. The damage to your vehicle was a direct result of the driver of the fleeing vehicle losing control of that vehicle and colliding into your vehicle causing damage.

It is our position that the City has no negligence in this matter, and cannot accept liability for the damages to your vehicle. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
