
On March 28, 2008 you were sent a true and correct copy of the findings of fact, conclusions of law and recommendations of the Licenses Committee with respect to your application for a Class "B" Tavern and Tavern Dance license in which the Committee recommended that your Class "B" Tavern license be approved with a twenty-five (25) day suspension and the Tavern Dance license be approved with a ninety (90) day suspension. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of April 9, 2008 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of your right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time and place you did not appear, but you did file written objections to the report of the Licenses Committee. You were not represented by counsel.

Following consideration of the report of the Licenses Committee and your objections, the Common Council adopted the recommendation of the Licenses Committee by a vote of thirteen (13) Ayes and two (2) Excused to renew your Class "B" Tavern license with a twenty-five (25) day suspension and your Tavern Dance license with a ninety (90) day suspension for the premises located at 2691 South 6th Street in the City and County of Milwaukee, Wisconsin ("Cleveland's Lounge") based on items in the police report and neighborhood objections.

Said suspension of the Class "B" Tavern license is to be in effect from 12:01 a.m. April 10, 2008 through midnight, May 4, 2008.
