If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 07/16/2007, the applicant was cited in the city of Milwaukee for Impure Food, Water, Drugs or Ice.

3. On 04/29/2012, an officer at District four took a walk-in strong-armed robbery complaint that occurred at 4925 W Hampton Av (McDonald's). The victim stated at approximately 3:29PM he was at the restaurant to use the free WI-FI and observed a group of 7 to 9 subjects in the area of his table that started to encircle him. One of the B/M's punched him in the left cheek causing pain and dazed him. At which time, one of the B/M's took his laptop and another took his backpack. The total values of items taken were approximately \$550.00 without victims consent.
  4. On 05/22/2012, Milwaukee Police Department was dispatched to 4925 W Hampton Av (McDonald's) regarding a trouble with subject. The investigation revealed this assignment involved the same person the store manager had an altercation with back on 05/17/2012. The subject was not pleased with their order and threw a cup of soda at the manager. The manager told the employees not to serve this person in the future. The person stopped back again on 05/22 and the employees recognized her at the window but served her anyway. Again the subject was not pleased with her order and started threatening and cursing at the employees. The manager refunded the persons money and then the person tried to spit at the manager but it hit the drive thru window. The person was arrested and charged with Disorderly Conduct with a jury trial set for 04/08/2013 and also has a no contact order for the McDonald's.
  5. On 05/24/2012, Milwaukee Police Department was dispatched to N 49<sup>th</sup> St and W Hampton Av for a shots fired complaint. The investigation revealed that an argument ensued between a patron and restaurant employees at the drive thru window. The patron started causing a disturbance by threatening employees and kicking on the windows. As the patron left, an unknown actor in a vehicle followed, and started firing shots at the patron's auto.

6. On 05/22/2012 at 1:00pm Milwaukee police were investigating drug dealing and use in the area of North 49<sup>th</sup> Street and West Hampton Avenue. During this investigation, officers observed a drug deal take place between two subjects in separate vehicles while parked in the lot of the McDonalds (4925 West Hampton Avenue). Milwaukee police incident report #1221430077 filed.
  7. On 08/03/2012 at 4:13pm Milwaukee police observed a Ford Contour parked straight in an angle parking spot in the lot of the McDonalds (4925 West Hampton Avenue). A Ford Expedition parked next to the Contour, and a subject exited the Expedition and got into the back seat of the Contour. Marijuana was discovered in the Contour following a Field Investigation stop. Milwaukee police incident report #122160113 filed.
  8. On 09/10/2012 at 5:25pm Milwaukee police were flagged down by the manager at the McDonalds (4925 West Hampton Avenue) regarding a suspicious subject in the women's bathroom. Investigation revealed the subject had bought and consumed food inside the restaurant, then gone into the women's bathroom. After about 45 minutes the manager became concerned and discovered the subject in a stall, sitting naked sideways on the toilet. At this point, the manager flagged down police. Officers discovered the subject in a stall in the women's bathroom with heroin and drug paraphernalia. The subject was arrested and Milwaukee police incident report #122540143 filed.

9. On 09/28/2012 at 2:05pm a Milwaukee police officers observed a subject walking in the 4700 Block of North 49<sup>th</sup> Street while talking on a cell phone. The officer believes this subject had the appearance of someone addicted to opiates. This subject completed a hand to hand exchange with another subject then walked to McDonalds (4925 West Hampton Avenue) and entered the bathroom. A Field Investigation stop of this subject as he exited the bathroom revealed opiates and drug paraphernalia. The subject was arrested and Milwaukee police incident report #122720097 filed.
10. On 09/29/2012 at 1:30pm a Milwaukee police officer observed the passenger in a vehicle operating in the 4900 Block of West Hampton on a cell phone. This vehicle initially pulled into the parking lot of the McDonalds (4925 West Hampton Avenue), then drove away and parked in the lot of the BP gas station at North 51<sup>st</sup> Street and West Hampton Avenue. The officer believes a drug transaction took place at that time between the occupants of this vehicle and a subject that walked to the driver side of the vehicle. Officers stopped the vehicle at 4925 West Hampton Avenue and discovered opiates inside. Both subjects inside the vehicle were arrested and Milwaukee Police Incident Report #122730099 filed.
11. On 10/03/2012 at 2:00pm a Milwaukee police officer observed a Lincoln Sedan with a driver and passenger inside in the parking lot of McDonalds (4925 West Hampton Avenue). A short time later, a silver truck parked on North 50<sup>th</sup> Street. The driver of the silver truck and driver of the Lincoln Sedan exited their vehicles and met in the parking lot. The officer believes a hand-to-hand drug exchange took place at that time. Officers stopped both vehicles and recovered Oxycodone Hydrochloride from both subjects. Milwaukee police incident report #12770084 filed.
12. On 10/17/2012 at 1:30pm a Milwaukee police officer observed a Hyundai Sedan in the parking lot of the McDonalds (4925 West Hampton Avenue) with the driver appearing to feed a baby. After a brief time, another subject exited the McDonalds bathroom and left the store without making a purchase. This subject got into the passenger seat of the Hyundai and the vehicle drove off the lot. The officer observed the Hyundai commit a traffic violation and stopped the vehicle. Heroin, Clonazepam, Suboxone and drug paraphernalia were discovered inside the vehicle. Both the driver and passenger were arrested and Milwaukee police incident report #12770084 filed.

15. On 07/14/2021 officers were dispatched to McDonald's at 4925 W. Hampton Av. for a Fight. The officers spoke with the manager, who stated there was a fight at the location and one subject fired a gun in the air in the parking lot. The manager had access to the camera system but the system was not working at the time of the incident.

16. On 05/07/22, at approximately 3:16pm, officers were dispatched to a Shooting at 4925 W. Hampton Av. Investigation revealed two subjects were seated inside McDonalds, when the suspects enter and begin firing guns at the subjects. The seated subjects return fire both inside and outside the restaurant. Two subjects were conveyed to the hospital for gunshot wounds and another was deceased. The employees were very cooperative with the investigation, allowing immediate access to video surveillance.

17. On 11/30/22 at approximately 8:04pm., officers were dispatched to Altered Currency at 4925 W. Hampton Av. Investigation revealed a customer placed an order at the drive-thru and attempted to pay with a counterfeit \$20 bill. The manager tested the bill and found it to be counterfeit at which time the customer became argumentative, however, eventually paid with valid us currency and left the location.

18. On 02/28/23 at 3:00pm, Milwaukee Police conducted a CAD (Computer Aided Dispatch) for police calls of services from 05/10/22 to 02/28/23 at the McDonalds located at 4925 W. Hampton Av. They are as follows with a brief description:

- 05/10/22 **Subj with Gun** CAD 22-130-0593: A female came to the location demanding to see the manager at the drive through window. The subject returned and stopped business at the drive through, possibly armed with a gun. The subject's action caused the staff to fear for their safety. The subject was located and arrested by Police.
- 06/20/22 **Threat** CAD 22-171-0719: Female subject made threats to staff member at the drive through window
- 07/01/22 **Trouble with Subject** CAD 22-182-1921: Caller was not allowed to see somebody at the location, Officers did not locate caller
- 07/04/22 **Trouble with Subject** CAD 22-185-1334: Caller ordered food and staff states the caller has a false receipt for food.

- 09/02/22 **Subject with Gun** CAD 22-245-2096: Subject in drive through pointed a gun at employee , suspects left prior to police arrival
- 10/27/22 **Property Damage** CAD 22-300-1664: Irate employee won't clock out and was throwing items around.
- 10/28/22 **Subject with Gun** CAD 22-301-1223: Subject upset over food order and pointed a gun
- 10/29/22 **Subject with a Weapon** CAD 22-302-0864: Subject refusing to leave making threats with a knife.
- 11/08/22 **Subject with Gun** CAD 22-312-1111: Subject waving gun around in the restaurant, upset because subjects were concerned for his child welfare. Subject was yelling don't saying anything to his child.
- 11/30/22 **Altered Currency** CAD 22-3334-1718: Altered currency used at the location
- 12/18/22 **Battery** CAD 22-352-0621: Customer threw food and attempted to strike employee
- 01/06/23 **Subject with Weapon** CAD 23-006-1803: Caller stated that a subject made threats to the caller regarding the use of a hand gun
- 01/31/23 **Threat** CAD 23-031-1484: Employee stated that subject refusing to leave and made threats to staff
- 02/04/23 **Trouble with Subject** CAD 23-035-0889: Subject being disruptive at location refusing to leave

19. On 06/13/23 at 9:40am, Milwaukee Police were dispatched to 4925 W. Hampton Av, for a property damage complaint. Officers spoke with the employee who stated that a subject was irate yelling profanities, and throwing items in the restaurant. The subject was located by police and cited for disorderly conduct.
20. On 06/27/23 at 2:58pm, Milwaukee Police were dispatched to 4925 W. Hampton Av, for a theft complaint. Officers spoke with the employee who stated that a customer became upset over a food order. The subject went behind the counter and took the food order, while yelling profanities at staff. The subject then left the location without paying for the food.
21. On 07/25/23 at 3:01pm, Milwaukee Police were dispatched to 4925 W. Hampton Av, for a subject with weapon. Officers spoke with the manager who stated that a customer was upset after receiving their food order. The customer then drove around the business. The customer exited his vehicle, threw bricks through the glass doors and windows, of the business.
22. On 10/06/23, Milwaukee Police were dispatched to 4925 W. Hampton Av, for a subject with a gun complaint. Prior to arriving at the location officers spoke with the caller who stated that an employee lifted his shirt to display a hand gun when he complained about his food order. Officers spoke with the manager and none of the employees matched the description given by the caller. Officers found the complaint to unfounded and baseless.

23. On 10/23/23 at 3:20am, the desk officer of District 7 took a walk in an armed robbery complaint the victim stated that on 10/23/23 at 12:00pm his car was taken by gunpoint at the Mc Donald's parking lot located at 4925 W. Hampton Av. The victim stated that the two suspects approached him while he was in his vehicle parked on the business parking lot. The suspects order the victim out of his vehicle then took the vehicle driving it off the lot. Officers followed up at the business and the incident was not captured on video.

Dispatch) from May 10th, 2022, till today's date of the following address: 4925 W Hampton Av, (McDonald's) which is in the City and County of Milwaukee WI, in regard to the many calls for service addressed to this location. The following are some of the calls for service we have in the system for the above listed address.

**05-10-2022:** Subject with a gun - **CAD 221300593** - **IR# 221300070** - MPD Officers responded to the McDonald's located at 4925 W Hampton Ave, which is located in the city and county of Milwaukee, for a subject with gun complaint at 10:50 AM. Upon arrival they spoke with the employee who was the one that called for police identified as, Yesenia L JOHNSON (B/F 03-21-97), who was assigned to the drive through window. She stated that a vehicle pulled up to the window and a black female was operating the car. JOHNSON stated that the female demanded to ask for the manager working the day of the shooting. JOHNSON said that the female yelled this to her and stated, "I want to speak with the manager with the red dread locks that was here when my nephew got killed." JOHNSON said that she told the female that there was no manager with dread locks and that they wouldn't provide any information. JOHNSON stated that the female then stated, "That's fine I'll be back."

JOHNSON stated that she observed the same vehicle back around 10:47 AM and in the drive through lane again. She stated that there was a vehicle that was occupying the window that she was working when she saw the car. JOHNSON stated that the female parked her vehicle in the drive through lane tying up other customers behind her. The female then exited the vehicle and approached the window on foot next to the other customer. JOHNSON stated that she slammed the window closed fearing that the female was armed with a gun. JOHNSON said that she and other employees ran to the back of the store fearing that the female was going to cause them harm. She stated that the female's actions disrupted the normal operations of the business.

Suspect was taken into custody the next day.

**06-20-22:** Threat - **CAD 221710719** - CALLER SAID FEMALE THREW WATER AT THE DRIVE THRU WINDOW AND BANGED ON IT, SHE MADE THREAT TO BEAT UP CALLER, CALLER NOW MAKING THREAT TO BEAT HER UP, NO FURTHER INFO.
