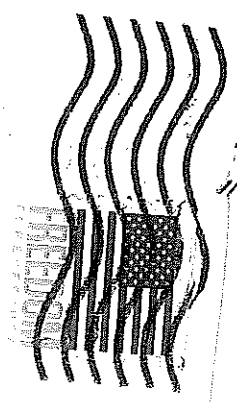

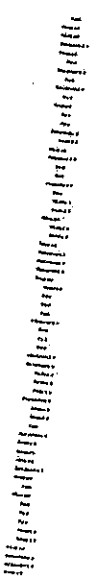

Dear Mr. Meier:

We have received your claim for the amount of \$5,473.52 in relation to the vehicle damage you sustained on September 1, 2023 in the area of the 2700 block of West Oklahoma Avenue.


Our investigation determined that a City of Milwaukee Parking Enforcement employee was traveling westbound on West Oklahoma Avenue in the right lane in the area of 2700 West Oklahoma. Attempting to turn right into the parking lot of St. Luke's Hospital, she turned her right turn signal on and proceeded with the turn when she collided with your vehicle. In response to this accident, she contacted her supervisor who responded to the location.

It is the position of Parking Enforcement that the accident was caused by your actions when you turned right from the left lane, in front of the City employee. Therefore, we cannot accept liability for the damages to your vehicle, and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
