3. **All 12' utility easements shown are deleted.**

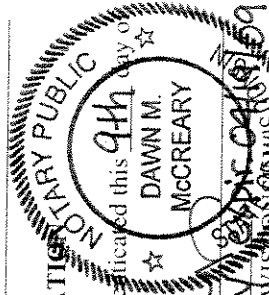
