If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffit, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

The following items pertain to the licensee and business located at 789 W. Layton Ave., Pita Palace.

- 1. On 05/26/25, at 5:25 p.m., an officer was dispatched to a Trouble with Subject complaint. An employee believed the owner's son called for police service, but he was no longer at the location upon the officer's arrival. No additional services needed.
- 2. On 05/31/25, at 4:00 p.m., an officer was dispatched to a Trouble with Subject complaint. The agent and a co-owner who rents part of the restaurant engaged in a verbal argument. Additional people were called to the business in an attempt to intimate the agent. There are two restaurants within the establishment, but only one business is licensed.
- 3. On 08/16/25, at 2:00 p.m., officers were dispatched to a Theft complaint. A subject entered the business and took three one hundred-dollar bills left by a customer on the front counter. The subject fled on foot but was followed by the business owner's family and eventually taken into custody by officers.
- 4. On 08/24/25, at 12:58 p.m., officers were dispatched to a Theft complaint. The caller stated she operate her own business called Jwonderland within the Pita Palace building, and the owner continues to turn off the thermostat on her side of the building.

The caller did not have a valid business license to operate. A Pita Palace employee provided officers a food dealer's license which expired on 08/13/25.

On Saturday May 31, 2025 at 4:00 PM, I was dispatched to the location of 789 W Layton Ave (Pita Palace) which is in the City and County of Milwaukee WI for a trouble with a subject incident.

Upon my arrival I observed that the restaurant was full of customers and had a special function or party taking place within the establishment.

I spoke to the caller/Owner, Yousef Audi ABDALLAH (A/M, 3-29-52, 309-222-7777). ABDALLAH stated that they had a argument with the other co-owner who rents out the other part of the restaurant. ABDALLAH stated that there lease agreement is over and wanted them to leave but, the other owner and ABDALLAH had a verbal argument in which the other owner thought was a threat made towards them. ABDALLAH stated that the other owner had called some friends or family members to come into the establishment to intimate them and others within the establishment.

Other workers at the establishment witnessed the incident as it occurred and sated the same thing with family coming in to pose a threat to the owner and staff.

I spoke to licensed premise owner ABDALLAH stated that they had an argument with the other co-owner who rents out the other part of the restaurant. ABDALLAH stated that there lease agreement is over and wanted them to leave but, the other owner and ABDALLAH had a verbal argument in which the other owner thought was a threat made towards them. ABDALLAH stated that the other owner had called some friends or family members to come into the establishment to intimate them and others within the establishment.

On Saturday, August 16th, 2025, squad 6543 (GUERRERO/J, ALMAS/H) was dispatched at 2:00pm to the location of 789 W Layton Ave (Pita's Palace) which is located in the City and County of Milwaukee, Wisconsin for a Theft call.

I was in Full Duty Uniform, with an activated body worn AXON camera and operating a marked MPD squad car with a working MDVR system.

Upon arrival I spoke to the victim and owner of Pita's Palace who was identified as Yousef A ABDALLAH (A/M DOB 03/29/1952) who stated at around 1:30pm a black male who was later identified as Jerry J LEE (B/M DOB 06/06/1988), had come into his restaurant and intentionally and without consent took 3 \$100.00 Bills in U.S currency which were placed on the front counter next to the cash register from a previous customer who had eaten there. ABDALLAH stated LEE was wearing a white t shirt and had dark colored pants. ABDALLAH stated his cousin, and wife had come to eat at the restaurant, and he insisted the meal was on him and they did not have to pay, but his cousin choose to do so and left the 3 \$100.00 Bills prior to him leaving.

I spoke to an employee at Pita's Palace who was identified as Angelica B MEDINA (DOB 05/27/2004) who also witnessed the incident. MEDINA stated at around 1:30pm LEE came into the restaurant and walked to the front counter of the business asking for a free drink. MEDINA states LEE stated how he had previously gotten free drinks from the restaurant in the past, but MEDINA wanted to verify this information, so she went into the kitchen area to ask her boss ABDALLAH. MEDINA stated when she went to ask her boss, LEE looked left and right before snatching the money and leaving the business on foot.

ABDALLAH showed me video footage where I observed LEE speaking to MEDINA in the front counter of the business prior to her going into the kitchen area to ask her boss ABDALLAH for permission to give him a free drink. I observed LEE in the video footage looking left and right before he took the 3 \$100.00 Bills in U.S currency and left the restaurant on foot.

ABDALLAH's son who was identified as Mjde Y ABDALLAH (A/M DOB 11-21-1979) followed the subject who had fled on foot and his walked his way west on W Layton Ave to 1215 W Layton Ave (Martino's) where he went inside of the restaurant. Mjde stated LEE locked himself inside of the bathroom when they confronted him and he refused to exit the bathroom. More squads arrived at the location of 1215 W Layton Ave and eventually Squad 6120 took LEE into Police custody.

I arrived at the location of 1215 W Layton Ave and spoke to Mjde who stated he followed LEE with his relatives to Martino's. Upon speaking to the other squads located there, they could not locate the 3 \$100 Bills in U.S currency that LEE had stolen. I searched LEE, incident to custodial arrest. I was about to pull LEE out of the squad car and search him, LEE told me the 3 \$100 Bills in U.S currency were located inside of his sock on his right foot. I searched LEE and eventually searched the right and left sock, and I found the 3 \$100 Bills in U.S currency bundled up inside of his white sock on the right foot.

Pita Palace is a Middle Eastern Restaurant. The counter and place for ordering/purchasing is located at

On Sunday, August 24th, 2025, at 12:58 PM, Squad 6563 (Myself in Full Milwaukee Police department issued uniform equipped with Axon body camera activated and in a marked Squad), along Squads 6150 (PO STASZEWSKI Dale and Squad 6190 PO LESNJAK Sean) responded to Theft complaint, at Pita Palace, located at the address of 789 W. Layton Ave, in the City and County of Milwaukee.

Upon my arrival I observed Pita Palace operating on one side of the restaurant and another store, labeled as JWONDERLAND operating on the other side.

I spoke to the caller identified as Sharid BOYTHAYNA ALI (A/F, 09-12-1979). Sharid explained that she operates her own business, within Pita Palace, under the name of JWONDERLAND. I observed Sharid to have her own menu and cash register. Sharid explained that she is having problems with Pita Palace owners, who are continuing to turn off the thermostat on her side of the building. I asked Sharid if she had her own license, to which she stated she did not and explained that she operates under Pita Palace business. Sharid mentioned that she feels harassed by Pita palace owners.

I then spoke to ASSAD Wasim Ghazi (A/M, 09-11-2003) who stated he works for Pita Palace, which is his family's business.

When I asked if he could provide me with the Licensing information, he was not sure if he had it. ASSAD then found Food-dealer restaurant license FREST-0021467, Effective date 08/14/2024- Exp Date: 08/13/2025.

I did not talk to license premise owner at this time. ASSAD stated the thermostat should not be in use by Sharid.

Both parties appeared agitated with each other's presence.



The hearing before the Licenses Committee will take place on 10/21/2025 at 2:05 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
