The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/26/22 at 9:25pm, Milwaukee Police were dispatched to 633 W. North Avenue for a battery complaint. Investigation revealed that two employees engaged in a physical fight, one of them left, and brought back a group of friends to re-fight the employee. The manager broke up the fight, the victim did not want to talk with police, and the police conveyed her to her residence.
- 2. On 10/05/22 at 6:20am, Milwaukee Police were dispatched to 633 W. North Avenue for a burglary complaint. Investigation revealed that a subject broke out a window to the door on the southside of the restaurant and entered the building. There was damage to the register, the place was ransacked, and the circuit breakers were switched off. Unknown what was taken.
- 3. On 7/11/23 at 11:57a.m., Milwaukee Police conducted follow up regarding a theft that occurred on 07/09/23 at 633 W. North Av. Investigation revealed a customer was in the drive-thru and was getting their change back, when a subject they had previously been arguing with, grabbed the change and fled the scene. The victim stated upon going to the counter to pay for his food, as he goes to grab his wallet out of his right back pocket the suspect grabs his wallet and runs out of Wendy's heading Northbound on 6th St. The victim stated he was not pushed and nothing physical happened. The victim stated he tried chasing the suspect but was too fast for him to catch. The victim stated his wallet was a brown Biker wallet, with no chain attached to it, and about 2inches thick. The victim stated his Social Security Card, Citco Gas credit card, Gray Discovery credit card, Library card, Educators debit card, WI Driver's License and with over \$100 dollars in cash inside.

Wendy's does have video footage of this incident to which the investigating squad sent an Evidence.com link to the Manager identified as Dave J. ## Initial observation/ scene description

Upon arrival on the scene at approximately 4:12PM, I observed the above located address is Wendy's. The business is a one-story brick building. The front entrance faces westbound. To the west and south of the building is a parking area, with a drive through to the southeast of the building.

## Interview of Jai KATHPAL (license premise employee)

Upon arrival, I observed 6 employees inside the store behind the counter. We were met by the complainant/ general manager identified verbally as David J. AKINES (B/M, 02/24/1969, resides at 4542 South 23rd Street unit (# 3) phone number 414-263-7397). He reported a subject described as a black male, approximately 5'8, 160 pounds, early 30's, wearing a red skully mask, and red hoodie, dark green jacket, khaki pants, and black sneakers entered the store. AKINES reported the subject did not purchase anything and kept walking around being suspicious. AKINES further reported his employees observed a

black fire in his waistband.

Please note the subject did not cause a disturbance or threaten anyone, AKINES called because they concerned the subject was up to no good. Once officers arrived on scene the subject left the premises.

The business was cooperative with the investigation.

The business did not have security officers on scene.

I was able to retrieve documentation of the business Wendy's restaurant #2

I observed multiple permits posted inside of the gas station, behind the checkout counter. I also conducted a license premise check on the City of Milwaukee License Search website and the following were listed:
