### CITIZEN'S STATEMENT

On July 27, 2024, my vehicle (blue 2013 Hyundai Elantra - License Plate APN 9461) was stolen in front of my residence at 3783 S. 75th Street in the city of Milwaukee. That same day, an incident report was taken at Police Station District 6 by Office Povlick - Case Number C2407270090, including, all my current contact information at that time. Over the following 6 months, I checked periodically with District 6 and was told they had no further information regarding my vehicle. On Tuesday, February 18, 2025, I again contacted District 6 regarding my stolen vehicle and to update them with my new phone number of 608-312-6543. I was advised that the vehicle was recovered back in July of 2024 and then was auctioned off earlier this year. They stated they tried to contact me by phone and stated the phone was disconnected back in October 2024 - at that time I *still* had the phone number given at the time of incident report of 414-544-8471. At no time did I ever receive any correspondence regarding the recovery of my vehicle. I am requesting to be made financially whole for the loss of this vehicle.

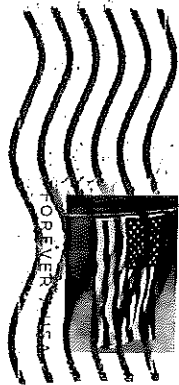

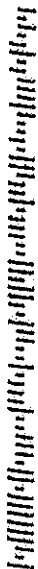
