BE IT KNOWN, That the City of Milwaukee, a municipal corporation of the State of Wisconsin, for valuable consideration to it in hand paid, the receipt whereof is hereby acknowledged, does hereby release the following described sewer easement, as shown in attached Plan File Number 53-1-71, located in that part of the Southwest one-quarter (SW ¼) of Section 24, Township 7 North, Range (21) East, in the City of Milwaukee, County of Milwaukee, State of Wisconsin, bounded and described as follows, to-wit:

The south six (6) feet of the north ten (10) foot strip of Lot nine (9), Block one (1), Noyes and Fuller's Subdivision No. one (1), in the Southwest one-quarter (SW 1/4) of Section 24, Township 7 North, Range 21 East, in the City of Milwaukee.

The above described property is a part of Tax Key Number 366-0908-000-5.

The aforementioned sewer easement was granted to the City of Milwaukee by Henry W. Marx and Elizabeth D. Marx, his wife, and Harley-Davidson Motor Company and was recorded in the office of the Register of Deeds of Milwaukee County on December 9, 1942 on volume 1871, page 229 as document number 2405097.

And in consideration of said payment, it does hereby remise, release and quitclaim forever unto Milwaukee Habitat for Humanity, Inc., owner; and to its successors and assigns forever, all and singular the tenements, hereditament and appurtenances thereto belonging.

The release of the sewer easement has been granted because there are no existing or planned sewer facilities in the said easement and no longer serve the public interest.
