STEVEN D. FORD MEMORIAL AWARD

NFBPA is committed to recognizing excellence in scholastic and professional achievement. In an effort to further the goal of "grooming and preparing younger, aspiring, public administrators for senior-level management positions," NFBPA offers the Steven D. Ford Memorial Award. 
THE MARY RUTH FOX MEMORIAL SCHOLARSHIP FUND
