There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkennes; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; thef; assaults; battery; acts of vandalism including graffit; excessive littering, loltering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to a for operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 5/20/2025 at 1:35 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

The Milwaukee Police Department's investigation regarding this application revealed the following:

 On 05/16/95, officers of the Vice Control Division of the Milwaukee police Department executed a search warrant upon the license premises at 3646 N. Teutonia AV, Catfish Lounge. Officers recovered a number of "pull-tab pools" from the bar.

2) On 01/26/96 at 2:12AM, officers observed that the lights were still on at the licensed premise at 3646 N Teutonia AV. Upon inspection, officers found that there were 11 patrons still in the tavern after legal closing time.

3) Incident: On 11/29/98, officers were dispatched to the Catfish Lounge located at 3646 N Teutonia AV regarding shots fired. Investigation revealed that one patron pulled out a handgun and demanded the wallet from another patron and during the altercation the subject fired two shots and ran out of the tavern obtaining nothing.

4) Incident: On 04/27/00, officers conducted a Battery investigation at the Catfish Lounge located at 3646 N Teutonia AV. Upon arrival, they interviewed bartender, Darryl Gladney, who they knew to be a convicted felon. Officers asked Darryl where the bar gun was and he showed officers where the gun was located. Officers placed Darryl under arrest for Felon in Possession of a firearm.

- 5. Incident: On 4-28-2002 a Clinton Hardiman was a patron in the Catfish lounge, 3646 N Teutonia Ave. Apparently a Tywanda Boston, who was also a patron, got into an argument with some of the other patrons. When Boston left the tavern, Hardiman followed her and offered to walk her to her car. After Hardiman walked her to her car, she left the scene, only to hear gun shots as she sped away. The victim, Hardiman, was found laying in the street. (Homicide)
- 6. Incident: On 5-27-2002 a Milwaukee Police Detective investigated a Robbery Complaint which occurred at the Catfish Lounge, 3646 N Teutonia Ave. A patron of the tavern had been struck in the head, knocked to the ground and had his wallet taken. The Detective talked to Laron Gladney, the licensee's son, who stated that James Gladney had moved to a new address. The licensee had failed to notify The City of Milwaukee License Division of this change. A citation was issued to James Gladney for the following:

- 7 On 12/20/09 at 9:30 pm, Milwaukee police conducted a License Premise Check at 3646 N Teutonia. Officers found two firearms in the taverns basement. Officers spoke to the bartender, identified as Darryl Gladney who denied any knowledge of the firearms. It should be noted that Gladney is a convicted felon and requested police to remove the guns, which were placed on inventory.

Teutonia Ave.). The victim reported being struck while in the business on 06/10/2011. Milwaukee police Incident Report #101620164 filed.

9. On 01/03/2011 at 1:07am Milwaukee police responded to the shooting at 3646 N. Teutonia Ave. (Catfish Lounge). Investigation revealed a patron of the bar had stepped outside for approximately 5 minutes, and when he again entered the bar, told security "Call 911, I've been shot". The victim had been shot while outside the bar. Milwaukee police incident report #110030022 filed.

- 10. On 10/17/2017 officers conducted a licensed premise check on The Catfish Lounge, 3646 N. Teutonia Av. The officer spoke with the bartender, Darryl GLADNEY, who stated there were no problems at the bar. The officer did not observe a food license posted but checked LIRA and found the tavern did have a food license issued. The officer advised to have the agent post the license.
- 11. On 12/05/2018 officers conducted a licensed premise check at The Catfish Lounge, 3646 N. Teutonia Av. The officer spoke with the bartender, Darryl GLADNEY, if they would be open on New Year's Eve. GLADNEY stated he would be open but he may close early depending on customer demand. He stated they would have security at the door that night and he wanted to avoid any problems with the bar down the street, Tha Competition, which has a younger clientele. No violations were observed.

- 12. On 02/07/24 at 10:44p.m., Milwaukee Police conducted a License Premise Check at 3646 N. Teutonia Av. No violations were found and the business was cooperative.
- 13. On 05/14/24 at 12:31a.m., Milwaukee Police were dispatched to a Shooting at 3646 N. Teutonia Ave. Investigation revealed this was an Armed Robbery that did not occur at the business. The business was closed at the time of the incident; however, the business was cooperative and allowed officers to view video surveillance.
- 14. On 12/06/24 at 9:51p.m., Milwaukee Police were dispatched to a Subject with Weapon at 3646 N. Teutonia Ave. Investigation revealed a suspect pointed a firearm at the victim, after they broke up a fight between patrons. The business was extremely helpful and cooperative, providing video surveillance of the incident.
- 15. On 02/15/25 at 1:56a.m., Milwaukee Police were dispatched to a DOE at 3646 N. Teutonia Ave. Investigation revealed this occurred in the upper private residence. Officers were advised a subject that often helps out at the bar with clean up, was found in the upper residence, unresponsive. MFD was on scene and performed life-saving measures, however, the subject was pronounced dead and conveyed to the ME's Office. No video surveillance was observed since this occurred in a private residence.

a scene of a Shooting complaint.

3646 N. Teutonia Avenue is a place of establishment named Catfish Lounge. This establishment is a bar that is located on the north side of N. Teutonia Avenue., with the front entrance facing west towards N. Teutonia Avenue.

Upon our arrival, I observed blood to the north of Catfish Lounge and two spent casings, north of Catfish Lounge. During the investigation, I also observed a human tooth near the spent casings and broken glass in the middle of the street.

I spoke with Laron M GLADNEY (B/M 05-21-71), who stated to an officer that his mother is the owner of Catfish Lounge and that he resides above Catfish Lounge. I did a record check on prior license premise reports and found that the owner is Jamie N GLADNEY (B/F 08-16-43). L. GLADNEY stated that he was watching television when he heard a "pop", believing that it was a gunshot, but then stated to himself that it couldn't be a gunshot.

GLADNEY stated that Catfish Lounge closed early, at midnight and that the bar was not open at the time of the incident. During the investigation L. GLADNEY was very cooperative and answered any questions I had regarding Catfish Lounge.

I observed multiple surveillance cameras on the exterior of Catfish Lounge:

- Surveillance Camera on southeast of Catfish Lounge, facing south
- Surveillance Camera on southeast of Catfish Lounge, facing west
- Surveillance Camera on northeast of Catfish Lounge, facing north
- Surveillance Camera on northeast of Catfish Lounge, facing south

There are also multiple surveillance cameras inside of Catfish Lounge and a metal detector which is operable.

Surveillance cameras are operable and after a review of the video footage for the exterior, it appears that an armed robbery occurred (Unrelated to Catfish Lounge).

- Sunday-Thursday: 2:00 PM 2:00 AM
- Friday-Saturday: 2:00 PM 2:30 AM

I asked L. GLADNEY how many employees are usually working during open business hours and L. GLADNEY stated that there are normally two bartenders and two cooks.

- Class B Tavern License: Active Valid until 06-13-24 Pending Renewal
- Food Dealer Restaurant License: Active Valid until 06-13-24 Pending Renewal

Upon arrival, we observed that numerous people were discussing the incident and were clearly upset about what had occurred. We were initially able to make contact with one of the victims / security guard of the establishment at 3646 N Teutonia Ave. (Catfish Lounge)

INTERVIEW OF BLUFORD

Victim 2, who identified himself as *Alex L. BLUFORD (B/M 6-6-1992)* who stated that the entire incident began over an argument between an older B/M and a B/F. *BLUFORD* stated that he did not observe the entire incident but when he heard the commotion, he observed a B/M striking a female and when he had attempted to break up the fight, the second suspect (who pointed the firearm) grabbed his arm. *BLUFORD* stated he would like to press charges for the incdient. *BLUFORD* described the suspect as such:

DESCRIPTION OF SUSPECT 2 (S2)

Alias - "Mayweather"

Approximately 40 years old

Between 5'06" - 5'07"

Black and Gray "mink" coat with a matching hat and a black long-sleeved shirt when his jacket came off

Armed with a black handgun

BLUFORD stated that after he broke up the fight, **S2** brandished and pointed a black firearm at him when he was standing roughly 10 feet away. **BLUFORD** stated that **S2** then left the scene in an unknown direction.

I asked **BLUFORD** if there was available camera footage, to which he stated there was and lead me to a rear room attached to the kitchen where I was able to playback the video. The timestamps and sequence of events are listed below.

21:37 - Small argument ensues between B/F wearing Black jacket and Green pants (later identified as *Monique L. WILLIAMS (B/F 11-1-1994)* and S1 who is described as a B/M wearing a red, white and black letterman style jacket. Also wearing a black baseball cap with a yellow "P" on the front with light blue jeans and black tennis shoes. S1 appears to be between the ages of 45-52 years old.

21:38 - S1 walks away from the female group and goes to a group of all B/M (which S2 is apart of)

21:40 - S1 no longer with group. All male group begins speaking with group of females

21:41 - Female group begins gathering their belongings to leave

21:46 - S1 begins arguing with a B/F wearing a leopard print jacket who was part of the all female group. She was later identified as *Stephanie A. RUSHING (B/F 1-20-1964)* and as *RUSHING* is attempting to deescalate the situation, **S1** pushed her arm and immediately punches *WILLIAMS* in the face with a closed fist 3 times before knocking her down.

21:46:30 - S1 throws a fourth punch, connecting with WILLIAMS

21:46:43 - BLUFORD arrives and is attempting to separate the fight, which is when S2 grabs BLUFORD's arm to which BLUFORD responds by tackling S2 towards the western end of the building.

21:47:05 - Patrons on the west end of the bar being to scatter quickly

21:47:11 - S2 stands up and is seen wearing a black long sleeve shirt and his holding a small black firearm in his right hand

21:47:27 - S2 points firearm at BLUFORD and lunges at him.

21:47:34 - S2 is pushed out of the bar

21:48 - All members of the male group are no longer inside of the establishment.

After viewing the footage, I went back out in to the lobby to speak with **RUSHING** as I recalled seeing her inside of the bar upon our arrival.

RUSHING stated that the entire incident occurred due to **S1** thinking that **WILLIAMS** had "dissed his friend" although **S1's** supposed friend was no longer at the location. **RUSHING** stated that she was unaware of who anybody was during the incident.

I asked **RUSHING** if she knew who female was that was wearing the green pants and black jacket **(WILLIAMS)**, to which she stated she did and had somebody call her. P.O. JUNIOR spoke with **WILLIAMS** on the phone and she stated she would return to the bar to speak with officers.

INTERVIEW OF WILLIAMS

WILLIAMS arrived back at the bar and recalled the sequence of events and stated that she S1 thought that she was dissing one of his friends and after he had come up and confronted her, she dismissed him and began telling her mother about what had happened. WILLIAMS then stated that S1 was reading her lips and attempting to intrude on their conversation when everything escalated and S1 struck her in the face.

WILLIAMS stated she was uninjured and did not need medical but that the assault did cause her pain and she would like to press charges.

It should be noted that all employees of the establishment were extremely cooperative and helpful during the investigation.

I observed all of the available licenses on the northern wall of the establishment and the bartender, who is identified as *LaSonia R. VIRGIL (B/F 6-15-1969)* gladly showed me where the licenses were located and was cooperative in giving me her information.

"This report is being written by P.O. DanYatta BROWN assigned to District 5 Late power Shift Squad 5438.

On Saturday February 15, 2025 at approximately 1:56 A.M my partner P.O. DeAngelo JUNIOR and I were dispatched to a DOE complaint at 3646 N Teutonia Ave located in the City and County of Milwaukee. On this day I was equipped with my Axon body-worn camera.

Upon arrival, I was instructed to the upper part of the building by MFD who was on scene at the time. The upper unit is an apartment the owner of Catfish Lounge, Laron GLADNEY (B/M 05/21/1971) resides in. I went upstairs and observed MFD in the kitchen (Engine 21, Blue Shift, LT PICKETT) performing CPR on an unknown female. P.O. JUNIOR spoke with GLADNEY while I went downstairs where the lounge is located and observed approximately 5 other individuals there along with GLADNEY. I spoke to the **caller** who verbally identified as Arrian JACKSON (B/F 04/04/1994) and called from the lounge phone 414-445-3505. JACKSON stated Laron told her "Jean" was bleeding from the nose and mouth and to call 911. JACKSON stated they know the woman as "Jean" and she comes there and helps Laron clean up. JACKSON stated she observed blood coming from "Jean's" nose and mouth and could see the life leaving her, JACKSON conducted CPR on "Jean" who was later identified by an identification card as Hester HOLMES (B/F 11/04/1954).

James GLADNEY (B/M 08/16/1993) stated he was in the kitchen of the lounge taking the garbage out at the time of the incident. Myles GLADNEY (B/M 06/07/1999), Derrick KING (B/M 08/09/1999) and the boyfriend of JACKSON, Camron NEWBON (02/10/1993) were also downstairs at the time. KING, James and Myles stated "JEAN" helps out around the lounge with cleaning and taking out trash. More squads were called to the scene because of the number of people in the lounge, and a supervisor were requested to the scene. MFD called time of death at 2:11 A.M. P.O. GONZALEZ and P.O. RIOJAS (Squad 5320), P.O. LABENSKY and P.O. PETTERSEN (Squad 5468) and SGT COBRAL (Squad 5313) responded.

While walking through the apartment, there was a hanger observed on the kitchen table with a burnt tip, pieces of a scotch brite scrub pad in the ashtray, and an unknown pill. Blood was observed in GLADNEY's

bedroom trailing to the kitchen, and puddles of blood in the kitchen. HOLMES was transported to the medical's examiner's office at approximately 4:48 A.M.

The business was *cooperative* with the investigation. The business had no security officers on scene. There were no cameras observed inside the upper residence.

While on scene, I observed the licenses posted and they were up to date. During my investigation for a DOE, I did not observe any violations in the licensed premise.
