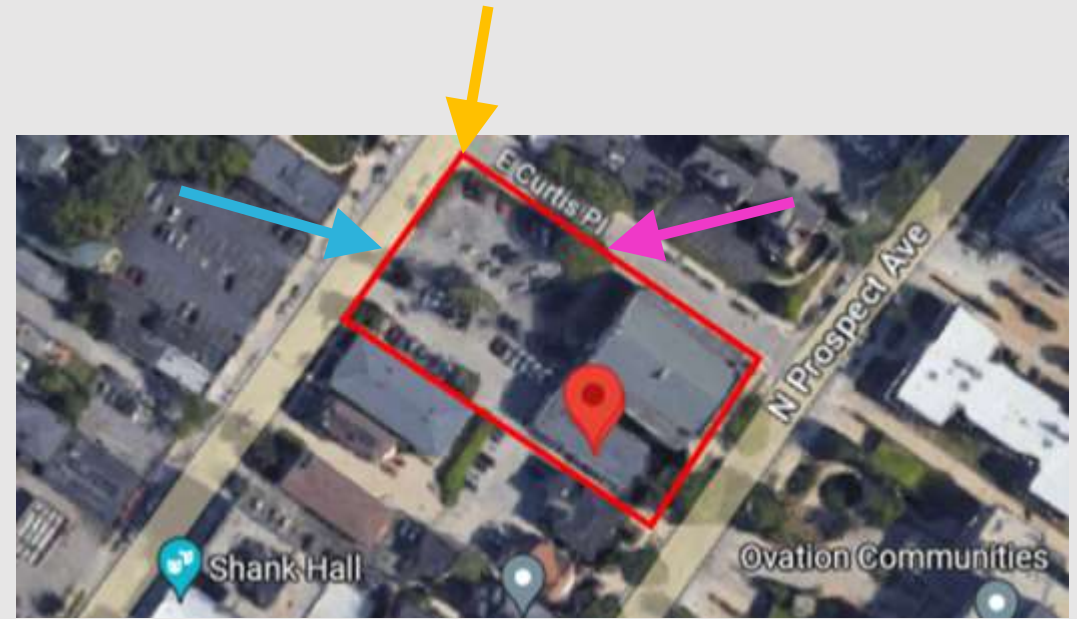


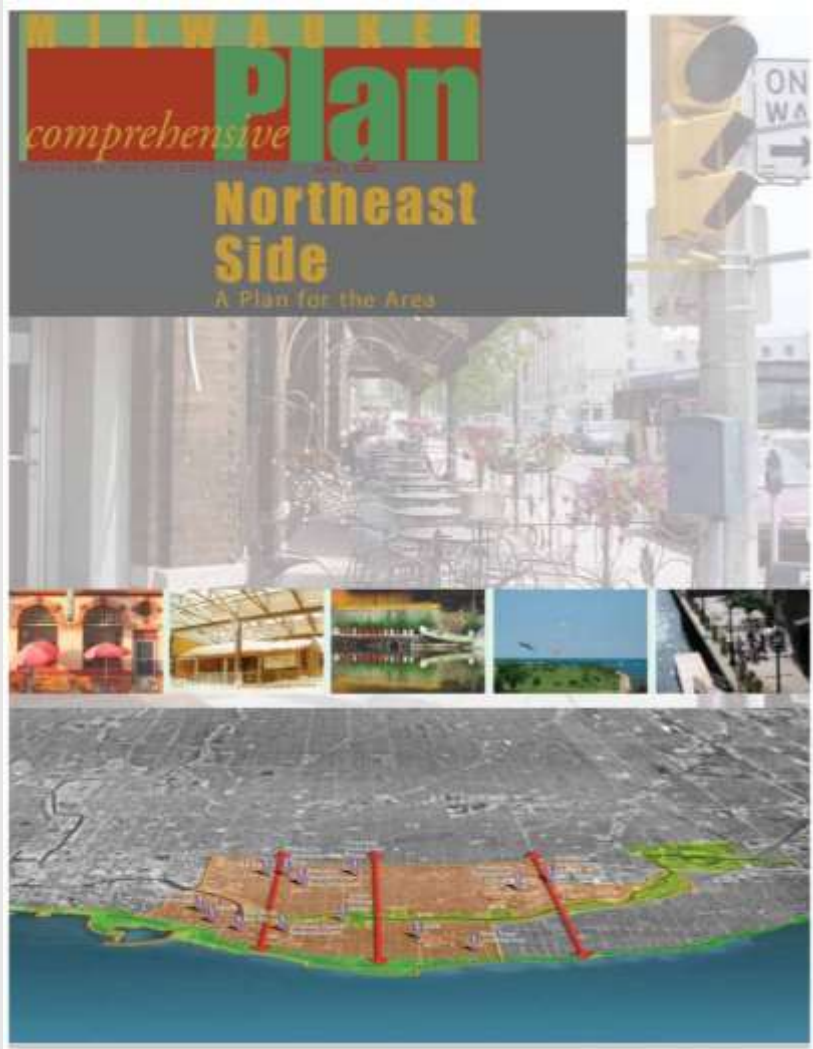

Northeast Side Area Plan:

- Adopted in 2009. Amended in 2012 and 2018.
- Recommends high-density transit-oriented development in areas well served by public transit
- Prioritizes the preservation of existing buildings that add to the historic character of the area
- Proposed building will add to the City's skyline while integrating with the older surrounding context through the use of high-quality materials and façade articulation
- **The proposed DPD amendment is consistent with the Northeast Side Area Plan**

SUMMARY OF CHANGES:

- REDUCTION OF ONE LEVEL OF PARKING
 - REDUCING FROM 25 TO 24 STORIES
 - MAINTAINS 1:1 PARKING FOR RESIDENTS AND RENAISSANCE PLACE & CONSULATE PARKING REQUIREMENTS
- INCREASED UNIT QUANTITY FROM 314 TO 346
 - UNIT MIX WAS ADJUSTED TO PROVIDE ADDITIONAL 1 BEDROOM & STUDIO UNITS
- REDUCED SF OF TYPICAL FLOOR PLATE AT WEST ELEVATION OF TOWER
- MODIFIED SIGNAGE
 - REMOVED WALL SIGNAGE ON NORTH FAÇADE
 - CREATED BLADE SIGN ON WEST FACADE

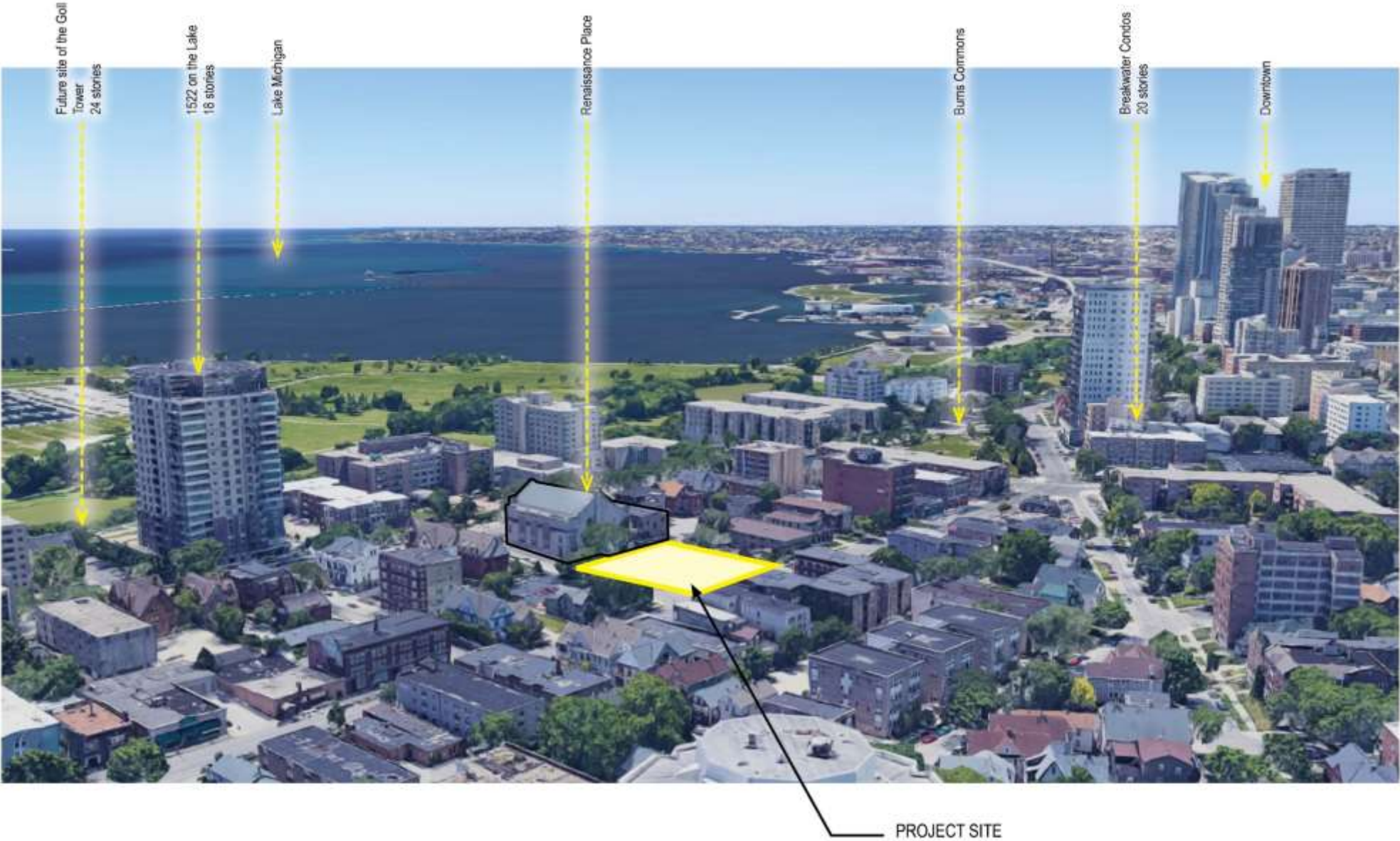

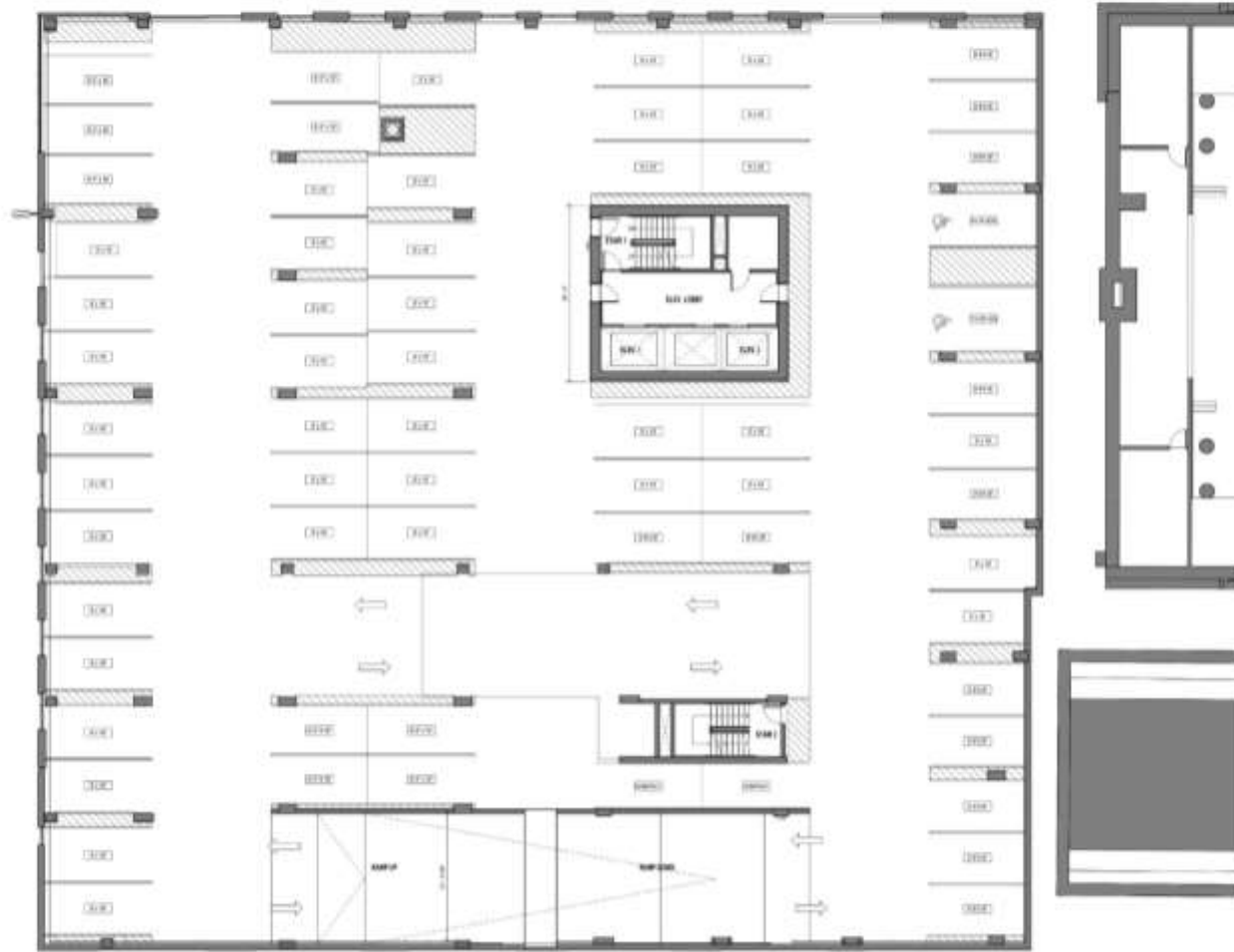
