

Dear Mr. Hubbard:

We have received your claim in the amount of \$225.00, relating to costs you incurred on July 31, 2006 when you allege that a plugged City sewer caused backwater to get into your property located at 3768 North 3<sup>rd</sup> Street.

Our investigation reveals that the Infrastructure Services Division records indicate that they investigated a backwater at 3768 North 3<sup>rd</sup> Street on July 31, 2006 and found that City 8-inch diameter sanitary sewer was clogged with grease. The sewer was cleaned and restored back to proper working condition at that time. The sewer was examined by closed-circuit television the next day and was found to be in good condition. The 3700 block of North 3<sup>rd</sup> Street had one previous clogged sewer which occurred on March 5, 1967. The sewer is on a regular cleaning schedule and was last cleaned, prior to this incident, on March 18, 2004. Because the sewer is on a regular cleaning schedule and the City did not have any notice of problems with the sewer, the City cannot be held liable. Therefore, we are denying your claim.
