

RE: Claim for damage to personal property

Dear Members of the Common Council:

This letter is to serve as formal documentation of the circumstances that lead to filing the claim as required by Section 893.801(l) WIS, Stats. On July 2, 2014, while driving southbound on Milwaukee Street between Wisconsin Ave and Michigan St., I hit a large pothole with the front driver's side wheel of my vehicle. I was unable to react to the pothole due to the size of the pothole, as well as due to other cars around me at the time. The hard impact was felt and the vehicle's computer system alerted me immediately of the loss in tire pressure. My automobile is a 2015 Audi A3, just over 1 month old. I removed the flat tire and installed the spare tire. On the morning of July 3<sup>rd</sup>, I took the car to International Audi for inspection of the damage to the original 1-month old tire. After the Audi service repair representative inspected the tire, a cut close to the rim was noted. Due to the extensive damage to the tire, a replacement was needed. The total cost of replacing the tire was \$271.09, which is the amount I am requesting for reimbursement.

I would like the Common Council to review my claim with the attention required and to review the included photo showing the damage caused to the tire by the pothole, the invoice/statement from International Audi and receipt as proof of amount paid, as well as photos of the pothole in question and a photo of the tire taken by the Audi service representative. Please also take a moment to review the description of the damage made by the Audi service representative on the statement, which appears to be consistent with damage caused by a pothole. I am kindly requesting the cost to replace the tire for my 1-month old automobile be paid by the City of Milwaukee through the pothole claims reserve. My home address is 3641 East Lunham Ave, Cudahy, WI 53110. I swear by my statements made in this letter are true and would be happy to discuss the event in person.
