To Whom it May Concern:

My name is LaSonia Stennis and my husband was killed on Jan 20, 2020 in his truck, a 2002 Chevy Tahoe. At the time of his death, the truck was registered to him. Marko's truck was taken and kept for evidence. On March 16, 2023, Deon Staten was charged for Marko's death and Marko's belongings were expected to be released. Throughout the 3 year waiting period for justice to be served, on several occasions, I inquired about my husband's belongings which included his ring of keys and his truck. I was told every time that they would get back to me and/or that the belongings were being kept for trial. It was stated that at any given time the defense attorney and/or the jury could ask to view the evidence and if they gave me back his things before hand, the evidence would be tampered with and there would no longer be of evidence.

On March 29, 2023, I received a phone call from Ms. Sanetran Johnson, the Victim/Witness Supervisor explaining that my husband's belongings were ready for pickup. She also stated that there were good news and bad news. The good news was that the phones were ready to be picked up and the bad news was that my husband's truck had been sold through an auction on Feb 06, 2020. Later that evening, Ms. Johnson called me again stating that the detective she was in contact with, said that he had made a mistake on the date the truck was auctioned and the correct date was Nov. 22, 2021.

Ms. Johnson went on to explain that the detective stated that he wasn't sure as to why the vehicle was sold, and that he believed that maybe the vehicle was not in my husband's name. Also, the detective in charge stated that the person responsible for selling my husband's vehicle unauthorized, no longer worked for the department. So, to answer any questions that I had regarding the whereabouts of the keys and the truck was impossible.

In my husband's vehicle were my son's speakers and a lot of tools that I helped my husband purchase to be able to work on cars. I would like to be reimbursed for the vehicle, the lost of the tools, my son's speakers, and the cost to replace my vehicle key and my mother-in-law house key pad that was on that key ring.

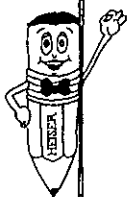

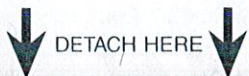
