This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/25/07 at 2:58 am, Milwaukee Police were dispatched to 5806 N 76th Street for a Armed Robbery Complaint. Investigation revealed that earlier, at about 1:30 am, the victim was at the gas station at 2707 W Burleigh getting gas and when he was getting back into his car, three men entered his auto and one held a gun to his back demanding the victims car. Officers spoke to the gas station manager who stated he was unaware of the robbery. Officers were able to view videotape that the manager provided officers.
2. On 04/27/07, Milwaukee Police along with an agent from the Department of Revenue were conducting tobacco enforcement investigations at 2707 W Burleigh. The agent found that there were no invoices for the cigarettes or blunt wraps. Some of the stamps were unreadable on the boxes of cigarettes. The agent confiscated the above items.

3. On 07/24/08 at 4:26 pm, Milwaukee police were conducting sales of tobacco products to underage persons and had a 15 year-old subject enter 2707 W Burleigh. The clerk, later identified as Asghar Choudry, sold a pack of Newport 100's without first asking for any ID. Choudry was uncooperative with police and at first refused to provide his ID when asked by police. A citation was issued to Choudry for Underage Tobacco Sale.

4. On 02/27/08 at 1:17 pm, Milwaukee police were dispatched to 2707 W Burleigh Street for an Armed Robbery complaint. Investigation found the victim pumped gas and left his car running while he ran inside to pay for gas. As the victim exited the store, he observed a subject running towards his car when the victim approach said subject, the subject then pulled a gun and pointed it at the victim firing several times but no shots were fired. The suspect then entered the victims' car and fled the scene. No injuries were reported.

Disposition added to item #3 02/19/2010

5. On 02/21/2009 at 1:43am Milwaukee Police, while on routine patrol, were flagged down by a citizen in the parking lot of the business at 2707 West Burleigh Street (A and I Petroleum). The citizen informed officers that he had observed 3 subjects running through the yards away from this location and that one of the subjects appeared to be armed with a handgun. Investigation revealed the business had been robbed at gunpoint (the weapon used was a BB gun) and that three actors had fled on foot. Police incident report #090520032 filed.
6. On 06/24/2009 at 4:00pm a 16-year-old subject, working in conjunction with Milwaukee Police on the Wisconsin WINS tobacco initiative, was able to purchase a pack of tobacco product from a clerk at 2707 West Burleigh Street (A and I Petroleum). The clerk, Asghar A. Choudhry, was cited for Sale of Cigarettes to Minor/Underage. This citation was later dismissed without prejudice in Milwaukee Municipal Court. The applicant was not cited.
7. On 01/26/2010 the applicant met with Lieutenant James MacGillis, Officer Minisha Howard and Officer Ray Robakowski, all of the Milwaukee Police Department, in the conference room at Milwaukee Police District #5 concerning the illegal activity around the licensee's properties. The applicant indicated he had recently installed drop safes in his businesses and that he makes cash pick-ups from the businesses during the day. He further stated that this business has 16 digital security cameras at the business with 4 of those cameras being outside and he welcomes additional police presence. The applicant states he has assisted police previously by providing DVD copies of surveillance footage from his security cameras and that he encourages his employees to both cooperate with police and to call if there are any problems. The applicant was provided with contact information for District #5 and the Community Prosecution Unit.

8. On 04/26/2012 Milwaukee police responded to a Battery/Robbery complaint at 2707 West Burleigh Street. Investigation revealed the victim was purchasing items from the business when the suspect attempted to take her purse from her auto. When the victim's boyfriend intervened, the suspect struck him in the head with a glass bottle. Milwaukee police incident report #121170024 filed.

9. On 01/12/2012 Milwaukee police conducted a security survey at 2707 West Burleigh Street in an attempt to combat some of the violent crime occurring in the area.

10. On 06/12/13 at 9:45am, a Milwaukee Police Officer along with an agent from the Wisconsin Department of Revenue conducted a licensed premises check at 2707 W. Burleigh St. (Gas Depot). The employee on duty was able to provide the agent invoices for cigarette and tobacco purchases. The licenses were current and posted. No violations were found.

11. On 09/23/19 Milwaukee Police were flagged down for a complaint of multiple subjects dealing drugs in front of the gas station located at 2707 W. Burleigh St. On arrival officers observed 6-8 subjects loitering in front of the location, who upon sight of the officers began to walk away. Upon entering the business officers interviewed a male sitting on top of a ice cream cooler. The subject was wearing a plain white t-shirt and blue jeans and notified officers he was security. The subject referred officers to a female in the store who he identified as being in charge. The female stated she owns the security company. Both individuals were uncooperative with police, refusing to identify themselves. The agent was notified via telephone and the subjects eventually provided identification. The clerk on scene was cooperative.

12. On 06/28/20 Milwaukee Police were dispatched to Gas Depot, 2707 W. Burleigh St., for a Shot Spotter call for service regarding 13 rounds. While enroute to the call officers were advised by dispatch there was also a trouble with subject call in which at least 15-20 cars were in the lot and people were dancing on top of vehicles and being loud. On arrival officers observed 75-100 people and at least 20 vehicles in the lot, blocking the driveways. Officers were able to disperse the crowd with no further incident. Officers interviewed the employee who stated the crowd began to gather earlier, then overflow onto W. Burleigh St. The employee was asked why he didn't call sooner; however, he could not provide an answer. The agent was contacted and advised of the situation. The agent stated he was aware this was an ongoing issue regarding subjects and his business.

13. On 03/05/21 Milwaukee Police conducted follow up at Gas Depot, 2707 W. Burleigh St., regarding a drug dealing investigation that took place in the lot earlier in the day. An officer spoke to the employee on duty and was cooperative and provided officers with video surveillance pertinent to the earlier investigation. Officers attempted to identify a security guard at the location, however, the subject refused to identify himself. Police contacted the agent and advised him of the investigation and he was cooperative acknowledging he is aware drug dealing is occurring in the lot and will make a better effort to contact police in the future.

14. On 04/23/2022 at 8:14pm officers were dispatched to a Shooting at 2707 W. Burleigh St. The officers found a subject shot to the chest lying on the ground by the front door. The officers interviewed the clerk, who stated the victim was the security guard. The clerk stated he heard two gunshots outside and observed people running. He then observed the guard lying on the ground. The clerk provided officers with access to the video surveillance system, which did capture part of the incident. The applicant arrived on scene and was cooperative with officers.

15. On 10/08/22 at 3:09pm, Milwaukee Police were dispatched to 2707 W. Burleigh Street for a subject with gun complaint. Upon arrival, an employee asked one of the officers to talk with the owner, on the phone, at a different location while another officer talked with a customer. Both officers left the store and talked to the owner who told them the subject one of the officers was talking to had a firearm. The officers went back to the store, found the subject to be unarmed and the subject refused to identify himself and left the store. After the subject left the clerk told officers the subject hid something and when they went to look, officers found a firearm hidden in a juice box. All the employees at the establishment were very cooperative.

16. On 10/05/22 at 6:50am, officers were dispatched to a Shooting complaint at 2707 W. Burleigh St. The business was cooperative with the investigation and allowed officers to view camera footage. The video show the particulars of the incident which occurred outside the location in the parking lot. One shot was fired and the spent casing was recovered on the parking lot of the location.

17. On 10/29/22 at 5:58pm, Milwaukee Police were dispatched to 2707 W. Burleigh Street for a battery complaint. Investigation revealed that a customer was upset and damaged property.

18. On 11/25/22 at 6:35pm, Milwaukee Police were dispatched to 2707 W. Burleigh Street for a theft complaint. Investigation revealed that a customer accidentally dropped money on the floor and another customer picked it up and refused to give it back. The subject was issued a citation.

19. On 04/08/23 at 11:45am, officers were dispatched to a theft complaint at 2707 W. Burleigh St. The employee stated that an unknown female suspect concealed a canned beverage in her purse. The employee confronted the female who became agitated over the incident refusing the claim and knocked over merchandise when leaving the store. The merchandise was not damaged and the employee provided officers a still photo of the suspect. The employee asked officers if the suspect is found and identified please relay that she was no allowed to patronize the store in the future.

20. On 04/18/23 at 11:38am, officers were dispatched to an armed robbery complaint at 2707 W. Burleigh St. The manager stated that the suspect entered the store and took two items and left the store without paying for them. The manger followed the suspect through the parking lot. As the manager followed the suspect, the suspect turned around and produced a handgun lowered at his side. The manager then walked backwards back to the store. The suspect was then observed leaving the area in a silver Kia northbound.

21. On 06/21/23 at 8:51a.m., Milwaukee Police were dispatched to a Theft at 2707 W. Burleigh. Officers were advised of several retail thefts that occurred on the same date. Two of the suspects were identified and issued citations. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

22. On 11/01/23 at 3:40p.m., Milwaukee Police were dispatched to a Fight at 2707 W. Burleigh Ave. On arrival officers were advised a subject was causing a disturbance and attempting to fight people outside of the gas station. Officers identified the subject who appeared to be in mental health crisis and intoxicated. The employee did not wish to prosecute.

The following items are Milwaukee Police reports regarding the license business at 2707 W. Burleigh Street, Gas Depot.

23. On 10/28/24, at 11:03 p.m., Officer responded to the business for Shooting. The victim walked into a local hospital. Officers were able to collect several bullet casings near the gas pumps confirming the shooting occurred in the parking lot. Security camera footage was available for reviewing. An employee stated there is a security guard employed, but they were not working that night.
24. On 01/16/25, at 7:57 p.m., Officers were dispatched to Threat complaint. The incident was not related to the business. The victim only went there to call for police service.
25. On 01/17/25, at 5:15 a.m., an officer was dispatched to Call for Police. No one in need of police service was located in the area.
26. On 01/26/25, at 11:24 p.m., officers conducted a License Premise check. Cameras were in working condition. All of the licenses were up to date and posted behind the counter. A armed security guard was on scene and stated their hours are 9:00 p.m. to 3:00 a.m. An officer found expired food items on display for sale. The employee and security guard were cooperative during the inspection.
27. On 03/23/25, at 11:00 p.m., officers were dispatched to a Subject with Weapon complaint. Security called to have a male removed that was in the business harassing other customers for money. No business violations observed.
28. On 04/11/25, at 8:16 a.m., officers were dispatched to a Trouble with Subject complaint. A subject was at the property with a dog refusing to leave. Upon arrival, police service was no longer needed.
29. On 05/08/25, at 10:04 a.m., officers were dispatched to a Theft complaint. The caller was found to be intoxicated and theft complaint baseless.
30. On 05/21/25, at 10:39 p.m., officers were on patrol and observed a possible stolen vehicle in the business parking lot. As officers were attempting to make contact with the occupants of the vehicle, several subjects exited and fled on foot. Officers were able to review security camera footage from the business. No business violations observed.
31. On 05/29/25, at 3:33 p.m., Officers were dispatched for a Welfare Check. Upon officers' arrival the subject was no longer on scene.

32. On 06/30/25, at 8:51 p.m., officers were dispatched to a Trouble with Subject complaint. A person known to deal drugs was at the location and the owner did not want them there. Upon officers' arrival an employee and security guard stated they did not call and the subject was gone.
33. On 07/07/25, at 10:34 a.m., Officers were dispatched to a Robbery complaint. A subject entered the business and stole items. The call was downgraded to a Theft.
34. On 07/17/25, at 1:57 p.m., community officers met with the alderman, local community leaders, and the business agent regarding community concerns and complaints. Items discussed were lighting, uniformed security guards, updating security cameras, cleaning, and additional meetings to discuss improvements.
35. On 07/22/25 at 10:48p.m., Milwaukee Police were dispatched to a Shooting. Investigation revealed the suspect and victim were involved in a verbal altercation outside, when the victim begins to run away, the suspect fired shots at the victim, striking them in the leg. The business was cooperative and allowed officers to view video surveillance.
36. On 08/17/25, at 1:34 p.m., officers were dispatched to a Subject with Weapon complaint. A subject was upset because he paid for gas but forgot to pump the fuel into his vehicle, and someone else took the gas. The subject took merchandise from the store, and as he was placing items into his car he displayed a handgun concealed in his waistband.
37. On 08/21/25, at 12:36 a.m., officers were dispatched to a Subject with Weapon complaint. The on-scene security guard did not see anyone with a weapon. A check of the business revealed the city licenses were not posted.

On Monday, October 28th, 2024, at approximately 11:03 PM, we were dispatched to 2707 W Burleigh St. (Which is in the City and County of Milwaukee) to assist in a shooting scene that occurred at that address.

Upon arrival Squad 5231 already had the business closed and taped off. We assisted in locating evidence and keeping scene secured.

It was confirmed the shooting occurred at this address and the victim walked into St. Joe's Hospital for treatment.

At the location of the scene, we had a total of 3 two man squads, 1 one man squad and a sergeant present for the scene.

No witnesses were on scene that talked to us or stated they saw anything.

The store employee was identified as Amridban SINGH (W/M 06/15/1993).

SINGH stated the store has 2 employees. SINGH stated the store does have armed security, but they were off tonight. SINGH stated they are open 24/7. SINGH stated the cameras work and record and allowed us to view them. SINGH was very cooperative during the whole investigation. SINGH was given a Milwaukee Police Department Community Contact Card.

I did not see the victim and do not know the injuries of the victim.

For a description of what was observed on surveillance, see Detective KOSCIELAK's supplemental report.

I observed all of the licenses valid and posted on the wall.

I did not observe a license pertaining to armed security though.
