

I wish to be considered for the vacancy in the Municipal Judge position, Branch 2 of the City of Milwaukee Municipal Court that became available as a result of the Honorable Louis B. Butler Jr.'s recent election to the Circuit Court of Milwaukee County.

I am currently a partner at the law firm of Machulak, Robertson & O'Dess We are a civil litigation firm, with a wide range of specialties in various areas of the law. My current practice consists primarily of family law, elder/guardianship and real estate law.
