Dear Mr. Murphy:

I have read a letter which is being passed around my neighborhood written by Claire Zellner of 3224 W. Scott Street, and regarding the Last Chance Bar, 3235 West Scott Street. As my house is directly across the street from this establishment, I felt I had to respond to the capricious statements made by Ms. Zellner. I, too, keep track of things happening with the bar, and I must say that my opinion differs greatly from hers. I will try to keep my letter brief, and appreciate your taking the time to read this.

First, her statements about music being played loudly at the bar on May 4th during the middle of the day, let alone on a Saturday, are unjustifiable. She has to remember that there are other people living in this neighborhood. I play my stereo a lot during the summer, especially every Saturday with my doors and windows open and believe me: my stereo is louder than the "jukebox" that is in The Last Chance Bar. As to the traffic problem complained of that night, and perhaps even some of the music that evening, same thing: other people live in this neighborhood. I had 5 friends over to my house for a card game that Saturday and all of them had to park somewhere. Tell me, am I the only resident of this immediate neighborhood that didn't have company over or park their own car on the street that particular evening? No. However, Ms. Zellner would have you believe that it is all from the bar. She even admits in her letter that the police told her to close all her windows and doors to shut out the music and street noise: that's because they had investigated the matter and found that the music was not too loud. And they don't just leave right away either. They sit around the corner; drive around a couple of blocks, and then come back a short while later and then sit in front of the bar. Then they sometimes come back without any calls to follow-up on the initial complaint. So when a police officer says that a noise complaint is unsubstantiated or it's not too loud, 1 believe them.

As for her statement "At 11:20 p.m., my neighbor went into the Last Chance Bar, and walked through the premises..." this is also not true. It was Claire herself. I was there and it was her. And as for minors being in the bar, perhaps she may not be well-traveled enough to realize that hispanic men sometimes look very young and are sometimes easily taken as being "under-age" when in a tavern. I know this from personal experience. Perhaps I was one of the patrons that she saw that night and thought was underage. Who's to know.

As to her statements that on Friday, May 10th and Saturday May 11th there were "loud patrons and bar noise being at very high levels..," this is also an absolute lie. No way on Earth would the undersigned tolerate something like which she is describing. It seems to me that she must have sat down with a calendar and picked dates to complain about without realizing that perhaps someone else in the neighborhood might find out about these stories she's hashing. Did she call the police on May 10th and May 11th when at 2:00 AM she supposedly "checked outside and the music was still cranking away"? If not, why would she call the police on the middle of a Saturday afternoon and not for these two, separate incidents? Go figure.

As to the paragraph of Ms. Zellner's letter concerning the events of Sunday, May 12th, I must tell you, Mr. Murphy, that the statements contained therein are even more pretentious. For goodness sakes, it was a Mother's Day party that The Last Chance threw for all of the neighborhood mothers, with free food, soda, and music for the mothers and their families. I was there with my mother and sister from 6PM until 10:30PM and never was the music very loud while we were there, nor afterwards. The police even stopped in, joked that they were there because someone was complaining about the noise, told everyone to "have a good time," and left. I have no idea what she was complaining about. It was a nice party. Perhaps she could have come to the party to break the ice and get to know some of the other neighbors. As for her statement that a car was parked "on the sidewalk" in front of the bar: I think she is sorely mistaken. There was a car parked oddly that night, but it was parked to the absolute corner of the street!

As to her statements concerning the property not being well-maintained and "...all this litter," I must tell you Mr. Murphy, we all suffer from the same dilemma in this area: candy wrappers, popsicle wrappers, soda cans, potato chip bags, etc., which are a daily problem because of the store on the corner, P&D Grocery, and I strongly feel that again, Ms. Zellner would have you believe that all of this is because of the bar. But that isn't true. Most of it is from the store. I pick up trash every day and I have seen Jose Mendez do the same, as well as other homeowners.

And as to "broken glass" in the area, perhaps she should tell her neighbor at 3228 W. Scott to stop having the "friends" that visit her house throw beer bottles and cans in the street, (which I have caught them doing on more than one occasion). Or perhaps it could have been the teenagers who I have seen gathered and drinking at the front of Ms. Zellner's own home in the past. Again, who's to know. But to just blame it on The Last Chance is not fair at all.

And finally, regarding what Ms. Zellner stated in reference to "...last summer the Last Chance told our neighborhood that we can complain all we want to the Milwaukee Police Department but it would do no good...", it's funny that she didn't mention this to the License Committee at the hearing in January. I'd like to know where she got that from and what other neighbors heard it because I'm in this neighborhood and nothing of the sort was ever said to me.

Mr. Murphy, as a sidenote, this neighborhood has a growing hispanic community in the immediate area. Because of this, young hispanic teenagers have been walking around the neighborhood and congregating on street corners, and sometimes even on people's porches. Needless to say, these kids make noise, carry radios, etc., and Ms. Zellner cannot take the noise attributable to the growth of a neighborhood and find a scape-goat to blame it on. While it is true that there were problems in the past, The Last Chance has made great efforts to keep the noise down, trash picked up and so on.

While I appreciate a new "watch-dog" on the block, who does Ms. Zellner think kept tabs on the bar before her? But I have not stopped, and that's why I had to send you this letter the moment I read the one written by Ms. Zellner. Just because she can't park her car directly in front of her house (when she has a two car garage), and have the air be constantly quiet, less the sound of a whispering breeze, she has to complain, complain, complain. She needs to remember: grocery store, traffic, neighbors, teenagers,....they all comprise things that make up noise in a neighborhood. If she's not happy with it, perhaps she should move to the country.

One last thing. If the license of The Last Chance is ever reviewed by the License Committee because of Ms. Zellner's or any other complaints, I would appreciate being notified of any dates for hearings, etc. for said review.

Again last Saturday, May 4th, 1996, our neighborhood experienced yet another assault of noise from the THE LAST CHANCE BAR at 33rd and Scott Street. I initially called the Milwaukee Police at 3:00pm for loud music. Apparently a band was having a practice session for the nights events. They took a break at 3:30pm and the police finally arrived at 4:30 pm. Of course, they didn't find any loud music. NOT VERY FAST RESPONSE FOR THE POLICE!!

About 6:00pm the traffic problems started, the loud music started soon after. At 8:30pm myself and two of my neighbors called the Milwaukee Police because of the noise. Approximately 9:45pm the police showed up at THE LAST CHANCE, UNABLE TO FIND A PARKING PLACE, they parked on the corner curb. AGAIN, SLOW POLICE RESPONSE!! The police went into the bar, came out, and left, without the music ever being turned down!! June was sufficient with police.

At 10:10pm the Milwaukee Police were again called to THE LAST CHANCE BAR for loud disturbing music and street noise. The police person who answered the phone told me to close all my windows and doors to shut out the music and street noise. My windows or doors were NOT open, in fact they are still sealed up for the winter with shrink wrap to keep out the cold.

DOES THIS MEAN I CAN"T OPEN MY WINDOWS ALL SUMMER LONG???

At approximately 10:55pm, a bar patron with a black pick-up (which had been parked in the area since 6:00pm) got into his vehicle and started squealing his tires. Unable to get out of his parking space, he started ramming the cars parked in front of and behind his vehicle. This went on for 10 minutes until the police DROVE BY at 11:05 p.m. (The police didn't even stop into the LAST CHANCE BAR at this time!!)

At 11:20pm, my neighbor went into the LAST CHANCE BAR, and walked thru the premises. There was a party in the hall with a live band and minors were in the bar area.

Friday, May 10th, and Saturday, May 11th were no different with the loud patrons and bar noise being at very high levels. At 2:00am Sunday morning I checked outside and the music was still cranking away. How would you like to come to my home and explain to my small children why we are putting up with this when they get stressed out from lack of quiet sleep time. Some nights they have cried themselves to sleep.....

Sunday, May 12th, the loud music continued. I first called the LAST CHANCE BAR and asked them to please turn down the music and their reply was 'GO AHEAD AND CALL THE POLICE'. So I called at 8:30pm, as did another neighbor. I swore out a complaint and the offices reported that when they entered the bar they could not even talk over the music noise. There is also no security provided in the area by the bar for noisy patrons leaving and disrupting the neighborhood by yelling, slamming car doors, letting their car alarms go off, squealing tires up and down the street, blocking traffic, and creating more traffic problems. Infact, Saturday, night May 11th there was a car parked up on the sidewalk in front of the LAST CHANCE!!

The license suspension earlier this year for 20 days did no good, as my neighbors and myself tried to argue at the liquior licence hearing. THIS IS A RESIDENTIAL AREA!!! We pay taxes and try to raise our children in a neighborhood of peace and quiet, to respect others and their property. The LAST CHANCE IS SETTING A BAD EXAMPLE FOR THE NEXT GENERATION to move into our area.

WHEN IS THIS GOING TO END? WHY ARE YOU NOT TAKING A STAND TO SOLVE THIS PROBLEM, AS YOU PROMISED WITH YOUR LAST ELECTION?? WHY DON'T YOU COME AND OBSERVE THIS PROBLEM AS WE HAVE INVITED YOU TO DO LAST APRIL???

We are half way thru May 1996 and haven't been able to open up our houses yet. There are elderly people in our neighborhood who feel as if we do, but are afraid to speak out, fearing property damage or harassment.

Manny and Vicki don't live in this neighborhood and just don't care as long as they are making money over the bar. Let's start fining them for disturbing the peace, having the police check for hall permits and capacity levels, and checking for underage drinking. The property is not being well maintained as you can see in the enclosed pictures. This property is a neighborhood eyesore. It is littered up and the crowd it attracts doesn't have respect for the neighborhood. How would you like to come home after working two jobs like I do and not be able to park on the street near yourhome, or if you did find a parking place to park, your tires are on broken glass and all this litter. I have to constantly pick up my front yard from junk and litter thrown out of cars near the bar.

Lat Saturday, May 11th, my son, Chris Stewart, found a spent gun shell outside the bar in the street. Let's hope this doesn't escalate into a bigger problem.

We want this place shut down because the suspension did nothing to deter the problems of the LAST CHANCE BAR.

Oh, and one more thing, last summer the Last Chance told our neighborhood that we can complain all we want to the Milwaukee Police Department but it would do no good because Manny has a relative on the Police Force who would pull all our complaints and keep them from being filed. We are keeping log books of how often we call the Milwaukee Police Department.

As I have been given differentiating information as to the process for the renewal of liquor licenses, I am quickly writing this letter.

- I, the undersigned, do hereby vehemently object to the application and/or renewal of any liquor license for The Last Chance located at the above address for the following reasons:
- 1. The music is played too loudly during late evening hours. Repeated requested to the bar owner, Manuel Mendez, have gone unheeded, as well as phone calls to the police seem to have no effect as they refuse to issue any citations for some unknown reason. Also, the door to his bar gets slammed, slammed and re-slammed throughout the evening until bar close which continously wakes me. And, further, the lights illuminating his establishment are an eyesore during evening hours.
- 2. Garbage. The front, sides and rear of the bar are constantly littered with trash including, but not limited to, beer bottles and cigarettes. Also, in the rear of the bar, broken glass has caused many tires to be flattened and the feet of neighborhood children to be cut creating unsafe conditions. During the summer, said refuse also includes thrown out food from his "gatherings" which draw mice and other pestilence to the area including stray dogs and cats.

- It is my understanding that The Last Chance does not have з. a cabaret license, yet Mr. Mendez continues to allow live bands to play in his bar for weddings and other cultural events. This is clearly in violation of municipal ordinance.
- parking. I, nor any guests/visitors to my home, can ever find any parking by my house because of the volume of people Mr. Mendez has coming and going out of his bar. His patrons also park in front of my garage slip barring my access to same. If I call the police, by the time they come, they are gone and they can do nothing except to tell me to complain to my alderman or pursue the remedy which I am now seeking.
- I, as well as others in my neighborhood have witnessed persons exiting The Last Chance and then urinating in other persons yards and on porches.
- It is my opinion that crime in the area has increased drastically since The Last Chance has been in operation.
- Mr. Mendez has repeatedly stated that he "....don't care what goes on out there" in the neighborhood, even though he and his patrons are the ones that are causing the problems.
- It is my opinion that drug and gang activities have been going on inside the bar but Mr. Mendez has stated that he "....don't care because they pay."

TAVERN'S NOISE, PARKING, TRAFFIC, FIGHTING, POLICE CALLS, AND MUSIC TROUBLES NOTHING HAS BEEN DONE. MY VEHICLES HAVE BEEN

HIT 4 TIMES IN FRONT OF MY HOME, THE MUSIC IS JUST AS LOUD, (EVEN THE BAR OWNER CAN'T HEAR HIS TRUCK ALARM GO OFF) AND I HAVE BEEN TO NUMEROUS LIQUOR LICENSE HEARING WHERE YOU GRANTED

THE LAST CHANCE ANOTHER YEAR TO STAY OPEN.

THE ENCLOSE PICTURES ARE FROM THE MORNING OF MARCH 18TH (MONDAY) AFTER ONE OF THE LAST CHANCE PATRONS MOWED DOWN THE SIGN THE NIGHT BEFORE. THESE TYPE OF THINGS GO ON CONSTANTLY. LOOK AT THE RUTS IN THE GRASS. THE SIGN WAS EVENTUALLY MOVED TO THE BAR'S SIDE OF THE STREET AND 'DISAPPEARED' NEVER TO BE REPLACED OR REPORTED (UNTIL NOW).
