I am one of four founders, who executed the Non-Stock Articles of Incorporation on May 12, 1992 to form Northeast Milwaukee Industrial Development Corporation, Inc. (NMIDC); which later changed its name to Riverworks Development Corporation on December 18, 2003.

Additionally, I am one of four founders, who executed the Non-Stock Articles of Incorporation for the Martin Luther King Economic Development Corporation.

I have also been a City of Milwaukee Planning Commissioner since 1994.

I am currently the Executive Vice President of the Inner City Redevelopment Corporation (ICRC) in Milwaukee, Wisconsin. I directed and managed ICRC's ownership of the 31,000 square foot commercial space, Brooks Plaza from 1989 to April 2011.

I also spend much of my time now, overseeing ICRC's 72-units of affordable housing in urban Milwaukee and the development of other projects.

Additionally, I serve as the Coordinator for the Harambee Great Neighborhood Initiative.
